Gentlemen:

The initial Bone Spring Formation Participating Area "B" is hereby approved effective as of March 30, 2018, pursuant to Section 11 of the Bell Lake Unit Agreement, Lea County, New Mexico. This participating area has been designated NMNM68292I.

The application establishes an initial Bone Spring Formation Participating Area "B" of 480.03 acres and is based upon the completion of unit well No. 230H, located in the NE $\frac{1}{4}$ SE $\frac{1}{4}$ (SHL) of Section 6, T.23S., R.34E., unit tract No. 7, lease No. NMNM01244A, and in the NE $\frac{1}{4}$ NE $\frac{1}{4}$ (BHL) of Section 31, T.22S., R.34E., unit tract No. 42a, lease No. NMLC70544A, with an initial potential of 1,132 BOPD and 1,982 MCFPD, from the Bone Spring Formation.

Copies of the approved request are being distributed to the appropriate agencies and one copy of Exhibits "A" and "B" are returned herewith. Please advise all interested parties of the approval of the initial Bone Spring Formation Participating Area "B" effective as of March 30, 2018.

Any production royalties that are due must be reported and paid within 30 days of the Bureau of Land Management's approval date or the payors will be assessed interest for late payment under the Federal Oil and Gas Royalty Management Act of 1982 (30 CFR 218.54). 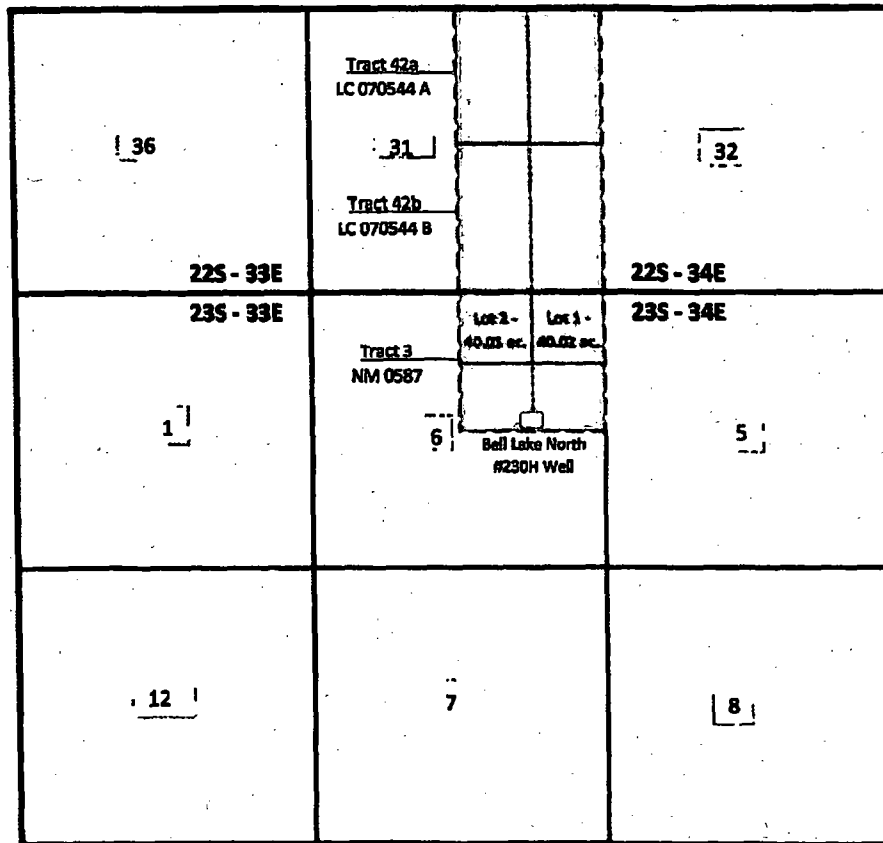
