

Santa Fe Energy Operating Partners, L.P. hereby requests administrative approval for an unorthodox surface location and directional drilling for the following well:

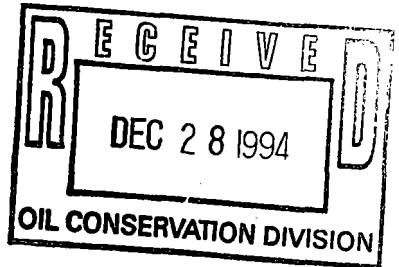
Farewell "18" Fed. Com. Well No. 1

Surface Location: 1026 Feet FNL and 409 Feet FWL
Bottomhole Location: 660 Feet FNL and 1980 Feet FWL
Section 18, Township 22 South, Range 26 East
Eddy County, New Mexico

The well will be drilled to test the Morrow formation (undesigned Happy Valley-Morrow Gas Pool). The N½ of the section (Lots 1, 2, E½NW¼, and NE¼), comprising 318.35 acres, will be dedicated to the well.

Due to extremely rugged topography, Santa Fe Energy requests approval of the above surface location, which is on an existing drillsite. Enclosed as Exhibit A is a topographic map of the area, outlining the well unit and highlighting the proposed surface location. Santa Fe Energy proposes to drill to a standard bottomhole location, as indicated above. The proposed well is located on Federal Lease NM 83054. The APD for the well is attached as Exhibit B, and Form C-102 is attached as Exhibit C. Santa Fe Energy was verbally notified by the Bureau of Land Management on December 21, 1994 that the APD has been approved.

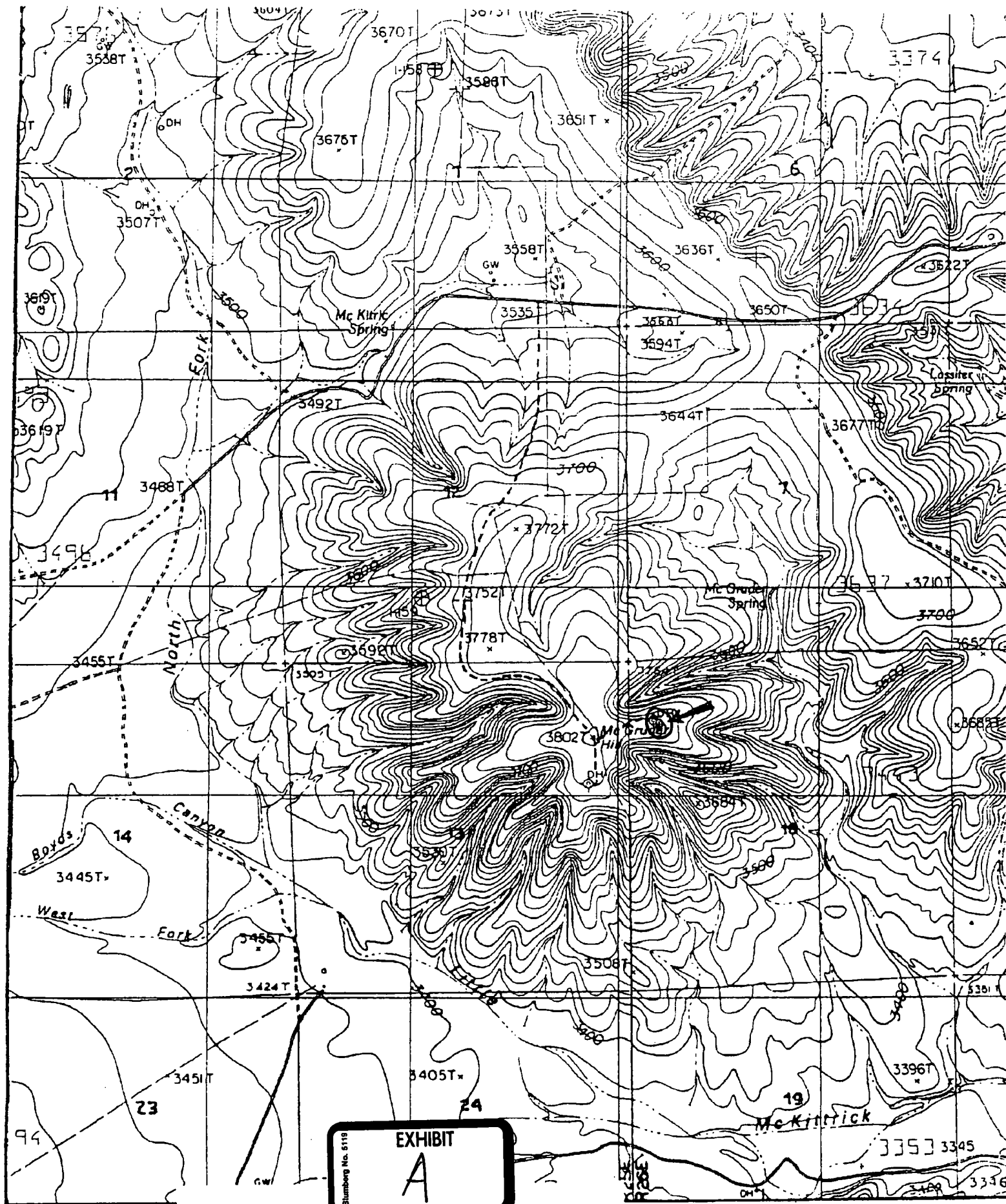
