Gentlemen:

Reference is made to your letters of November 17 and December 6, 1965, wherein you request an exception to Rule 107 (d) (2) to permit the production of gas from your Hagerty Federal Well No. 8 located in Unit E of Section 7, Township 16 South, Range 30 East, West Henshaw Grayburg Extension, Eddy County, New Mexico, through 4 1/2 inch casing.

Inasmuch as a recent test of the well indicated a dry gas with no liquids being produced, flowing the well through the casing should present no production problems nor cause waste. The Commission, therefore, has no objection to flowing the well through the casing and exception to Rule 107 (d) (2) is hereby granted. The Commission does reserve the right, however, to rescind this order in the event that inefficient flow is later indicated.

Gentlemen:

We hereby request an exception to Rule 107 (d) sub-paragraphs (2) and (3) concerning the captioned to permit this well to be produced without tubing.

The subject well was drilled to a total depth of 2658' and 4-1/2'' casing was set and cemented at 2600'. A 4-1/2'' Orbit valve was installed on the casing and the well was completed from the open hole in September, 1959, as a shut-in gas well.

On a test through the 4-1/2" casing in September, 1959, the well flowed 2,000 MCF of gas and had a bottom hole pressure of 728 pounds per square inch.

We intend to utilize the well as a gas supply to gas lift oil wells on the same lease producing from the same zone. The gas will then be processed through a gasoline plant.

We feel that no waste will be incurred by producing the well without tubing and would greatly appreciate your approval of this request. Please advise if you need further information.
