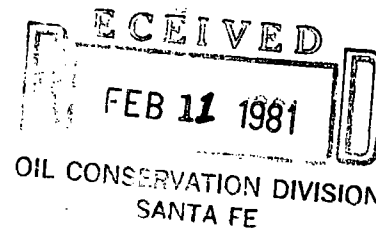

Dear Mr. Ramey:

Exxon Corporation respectfully requests an administrative exception to New Mexico Oil Conservation Commission Rule 107 (d) (3) for the above well.

The well is producing from the Atoka formation through casing perforations 11,372-11,378 with tubing stung into a dual packoff assembly at 10,307 feet. The well produced dry gas (SG=0.583) on a four point test with the following results:

We believe that no waste will be caused by producing the well in this manner.
