Gentelmen:

The Eastland Oil Company Fortson Federal Com. #1 was completed February 9, 1983, at a total depth of 13,020 feet. The attached schematic sketch shows the tubular settings and completion information.

The MWL Insert Seal Assembly is on the hottom of the 2 3/8 inch, N-80 tubing and is seated in the MWL PBR at (10,344) feet. The 4 1/2 inch liner was perforated with a tubing gun from 11,873 feet to 11,919 feet in the Atoka formation.

Since this completion resulted in the tubing setting being at a distance of 1529 feet above the top of the producing interval, it does not comply with Rule 107 (d) (3) which specifies that the tubing not be more than 250 feet above the top of the pay. It is repectively requested that an exception be granted as provided in Rule 107 (d) (4).
