Re: Amended Application of Solaris Water Midstream, LLC to permit for salt water disposal in the proposed Klein 6 SWD #1 well to be located in Section 6, Township 20 South, Range 35 East, NMPM, Lea County, New Mexico

Dear Ms. Sandoval:

The original application stated that the surface location of the Klein 6 SWD #1 well would be 236' FSL and 508' FWL in Section 6, Township 20 South, Range 35 East, NMPM, Lea County, New Mexico. The amended location will be 236' FSL and 275' FWL, in Section 6, Township 20 South, Range 35 East, NMPM, Lea County, New Mexico. There are no other changes to the original application.

Enclosed is an amended form C-102 showing the correct footage calls for the surface location along with the correct plats and maps showing the revised location. This amendment is being made to satisfy concerns by COG Production, LLC. COG did not file a formal objection to the application but communicated with Solaris via telephone urging re-location of the well. Their concerns have been addressed and COG is satisfied with the new location. This was confirmed with a phone call between Solaris and Mr. Brad Holland of COG Production, LLC who agreed with the new footage calls.

This change in location will not affect any other part of the application. The new AOR does not include any wells that were not addressed originally. Further, no additional adjacent operators were identified after the move, so no additional notifications are required. All other attachments to the original C-108 have not changed. The surface owner remains the same, however, Solaris is copying them on this letter so that they are aware of the new location.
