Apache Corporation would like to amend the production allocation percentages on downhole commingle permit DHC-2365 to reflect the current producing pools. The original permit includes the Blinebry Oil & Gas (Oil – 06660) pool which has not been completed in the D C Hardy # 4.

Prior to completion of the Tubb Oil & Gas (Oil – 60240) pool, the DC Hardy # 4 was producing 6 BOPD x 60 MCFD from the Drinkard (19190) pool. The Tubb pool is currently testing at 9 BOPD x 0 MCFD. Based on this, we request an amendment to the allocation as follows:

Tubb Oil & Gas Pool	Oil – 60%	Gas – 0%
Drinkard Pool	Oil – 40%	Gas – 100%
