Marathon had previously applied and been given permission by the NMOCD to dedicate 80 acres comprised of Unit Letters G & H of Section 24, Township 22 South, Range 37 East to production from the Tubb Oil & Gas pool to Marathon's two J. L. Muncy wells:

**J. L. Muncy No. 7 API # 30-025-29219** UL 'G', 2086 FNL & 1874 FEL, Section 24  
**J.L. Muncy No. 11 API # 30-025-33947** UL 'G', 2310 FNL & 1980 FEL, Section 24

These two wells are currently making less than half the allowed 9,210 mcf of gas that is allowed to 80 acres in the Tubb Oil & Gas pool. (Please see attached spreadsheet for well rates)

Marathon is seeking OCD approval to amend **NSP-1475-A** to include a Tubb completion in the


**J.L. Muncy No. 4 API # 30-025-22217** UL 'H', 1980 FNL & 660 FEL , Section 24

The J. L. Muncy No. 4 was briefly tested in 1968 before being cement squeezed in the Tubb formation. The well at that time was capable of producing approximately 740 mcf of gas with 30 barrels of oil per day. Marathon believes that the J.L. Muncy lease is depleted in the Tubb pool to the extent that in the best case scenario we would expect less than half that rate of flow, but the additional completion would allow us to recover addition reserves that would not be recovered without the completion. In the event that the well is capable of making enough gas to be over produced beyond NMOCD limits. Marathon would shut in one or more of the wells to bring production within allowable rates for the Tubb formation each month. At the present time the J.L. Muncy No. 4 is being produced as a downhole commingled well from the Blinebry and Brunson Drinkard Abo pools. It is Marathon's intention to submit to downhole commingle all three pools in the well after we have gathered sufficient information on production rates for the Tubb pool to establish commingle percentages for the different pools.

I have included in this application C-102 plats for the No's 4, 7 & 11. The C-101 & C-102 for the Tubb completion on No. 4 have been submitted to the NMOCD in Hobbs. A letter was attached with those forms to inform them that an amendment to NSL-1475-(L) (SD) was being filed with your office. Also included is a map of the J.L. Muncy lease with locations of the three wells.


