Mack Energy Corporation contract operator for COG Operating LLC respectfully requests administrative approval for down hole commingling and measurement of production.

COG proposes to commingle Baish Wolfcamp and Maljamar Abo production in the JC Federal #4 NMLC-029509B. Production of both pools will be measured at the JC Federal #4 TB located in the SE/4 NW/4, Sec. 22 T17S R32E. This lease has common interest in both pools. Notification has been made to all parties owning an interest in this lease, including the oil purchaser, of the intent to commingle. Testing will be conducted and allocation percentages will be sent to OCD after completion of this well. This well has produced for some time from the Wolfcamp formation. The subtraction method will be used to allocate production based on increased production from the Abo formation.




