Energen Resources Corporation, requests to downhole commingle the S. Blanco Pictured Cliffs and Blanco Mesaverde pools in the subject well. The well is currently producing as a Pictured Cliffs/Mesaverde dual completion. The Pictured Cliffs zone has experienced liquid loading problems and it is felt downhole commingling will eliminate excessive operational problems and allow the Mesaverde flow stream to aid in keeping the Pictured Cliffs zone unloaded and producing.






