**SECOND AMENDED
AGREED COMPLIANCE ORDER**

Pursuant to Ordering Paragraphs 3 and 5 of Amended Agreed Compliance Order 04-10-A, the Director of the Oil Conservation Division ("OCD") hereby amends that order as follows:

FINDINGS

1. Amended Agreed Compliance Order 04-10-A requires Latigo Petroleum, Inc. ("Operator") to return to compliance with OCD Rule 201 at least eleven of the wells identified in Exhibit A by June 30, 2006, and file a compliance report by that date.

2. Amended Agreed Compliance Order 04-10-A further provides that if Operator returns to compliance with OCD Rule 201 at least eleven of the wells identified in Exhibit A by June 30, 2006, and files a timely compliance report, the OCD shall issue an amendment extending the terms of Amended Agreed Compliance Order 04-10-A for an additional six-month period, requiring Operator to return an additional 11 wells to compliance by that deadline.

3. Operator filed a timely compliance report, and the OCD has verified that Operator has returned the following wells identified in Exhibit A to compliance:

CONCLUSIONS

1. Operator has returned 16 wells identified on Exhibit A to compliance, exceeding its 11-well goal by 5 wells.

2. The OCD should amend Amended Agreed Compliance Order 04-10-A to extend its terms through December 31, 2006 and require Operator to return to compliance by December 31, 2006 the 5 wells identified in Exhibit A that remain out of compliance.

ORDER

1. Latigo Petroleum, Inc. shall return to compliance by December 31, 2006 the 5 wells identified in Findings Paragraph 4, above.

2. Latigo Petroleum, Inc. shall file a compliance report by December 31, 2006 using the Oil Conservation Division's web-based on-line application.

3. The terms of Amended Agreed Compliance Order 04-10-A otherwise remain in effect and are extended through December 31, 2006.
