We are presently in the process of filing a C-101 and C-102 for our proposed R. W. Cowden "C" No. 10 infill Jalmat gas well to be situated at a <u>now-revised</u> location consisting of 1650' FNL and 330' FWL Section 31, T-23-S, R-37-E, Lea County, New Mexico. The R.W. Cowden "C" No. 10 Jalmat infill well will be simultaneously dedicated (along with our R. W. Cowden "C" No. 4 Jalmat well) to a new 236-acre non-standard Jalmat gas proration unit consisting of NW/4, W/2NE/4 Section 31, T-23-S, R-37-E.

In consideration of the foregoing, and in an attempt to both geologically separate and horizontally distance our proposed R.W. Cowden "C" No. 10 well from encroachment by Texaco's newly-drilled and newly-completed E.E. Blinebry "A" Com NCT-1 No. 4 gas well situated at an unapproved unorthodox Jalmat location consisting of 1870'FSL and 990' FWL Section 31, we are hereby filing for administrative approval to relocate our proposed R.W. 



Utz, Examiner duly appointed by the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission," in accordance with Rule 1214 of the Commission Rules and Regulations.

NOW, on this <u>3rd</u> day of May, 1963, the Commission, a quorum being present, having considered the application, the evidence adduced, and the recommendations of the Examiner, Elvis A. Utz, and being fully advised in the premises,

## FINDS:

(1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.

(2) That Order No. R-1949, entered by the Commission on April 28, 1961, established a 275.96-acre non-standard gas proration unit in the Jalmat Gas Pool consisting of the SW/4, E/2 SE/4 and NW/4 SE/4 of Section 31, Township 23 South, Range 37 East, NMPM, Lea County, New Mexico.

(3) That Order No. R-1949 dedicated the above-described non-standard gas proration unit to Texaco's E. E. Blinebry Well No. 2 at an unorthodox location 1980 feet from the South line and 660 feet from the East line of said Section 31.

(4) That the applicant, Texaco Inc., now seeks the establishment of a 355.96-acre non-standard gas proration unit in the Jalmat Gas Pool to be dedicated to its E. E. Blinebry Well No. 2 and consisting of the SW/4, N/2 SE/4, and SE/4 SE/4 of Section 31, and the S/2 SW/4 of Section 32, Township 23 South, Range 37 East, NMPM, Lea County, New Mexico. -2-CASE No. 2797 Order No. R-2474
