## SECOND AMENDED AGREED COMPLIANCE ORDER

Pursuant to Ordering Paragraphs 3 and 4 of Agreed Compliance Order 104 (ACOI 104) as amended by Agreed Compliance Order 104-A (ACOI 104-A) the Director of the Oil Conservation Division (OCD) hereby amends that order as follows:

#### **FINDINGS**

- 1. ACOI 104 as amended by ACOI 104-A requires XTO Energy Inc. (Operator) to return to compliance with OCD Rule 201 at least 6 of the wells identified in Exhibit A by July 31, 2006, and file a compliance report by that date.
- 2. ACOI 104 as amended by ACOI 104-A further provides that if Operator returns to compliance with OCD Rule 201 at least 6 of the wells identified in Exhibit A by July 31, 2006, and files a timely compliance report, the OCD shall issue an amendment extending the terms of ACOI 104 for an additional six-month period, requiring Operator to return an additional 6 wells to compliance by that deadline. And if Operator continues to return wells to compliance at a rate of at least 6 wells every six months, the OCD shall issue amendments extending the terms of the order for additional six-month periods, so long as the total time period covered by the order does not exceed two years.
- 3. Operator filed a timely compliance report, and the OCD has verified that OCD records indicate that Operator has returned the following wells identified in Exhibit A to compliance:

- 4. ACOI 104 as amended by ACOI 104-A also requires Operator to transfer all wells operated under OGRID 167067 to OGRID 5380 by July 31, 2006, and to operate all its wells under OGRID 5380.
- 5. By letter dated July 27, 2006, Operator requested a three-month extension of the deadline for transferring wells operated under OGRID 167067 to OGRID 5380, citing the large volume of C-115 corrections that need to be submitted for wells currently operated under OGRID 167067. Submitting the corrections under the current OGRID will be much easier than submitting corrections after the wells have been transferred to OGRID 5380.

#### **CONCLUSIONS**

- 1. OCD records indicate that Operator has returned 63 of the wells identified on Exhibit A to compliance, exceeding its 6-well goal for the first period under ACOI 104 by 57 wells, and exceeding its 24-well goal for the entire 2-year life of the order by 39 wells.
- 2. The OCD should amend the deadline for returning wells to compliance under ACOI-104 as amended by ACOI 104-A to extend its terms through February 1, 2008.
- 3. The OCD should extend the deadline for transferring wells operated under OGRID 167067 to OGRID 5380 until October 31, 2006.

#### **ORDER**

- 1. Operator shall transfer wells operated under OGRID 167067 to OGRID 5380 by October 31, 2006.
- 2. Because OCD records indicate that Operator has exceeded the 24-well goal for the 2-year life of ACOI 104 as amended by ACOI 104-A, Operator is not required to file additional compliance reports.
- 3. The terms of ACOI 104 as amended by ACOI 104-A otherwise remain in effect and are extended through February 1, 2008.
