

Dear Ms. Wrotenberry:

Greystone Energy, Inc. requests to downhole commingle the Blanco Mesaverde and the Basin Dakota pools in the subject well. The well is currently producing as a Dakota / Mesaverde dual completion. The well does exhibit signs of liquid loading problems and it is felt that downhole commingling will eliminate excessive operational problems. It will allow the energy from both formations to assist in lifting liquids. The removal of liquid accumulation will increase overall gas production.

To comply with the New Mexcio Oil Conservation Rules, Greystone Energy, Inc. is submitting the following data for your approval of the proposed commingling:

- 1. Form C-107A Application for Downhole Commingling
- 2. Form C-102 Location Plat showing each spacing unit and dedicated acreage
- 3. Production Curves for both the Dakota and Mesaverde
- 4. Working and Royalty Interest owner notification list
- 5. Bottom hole pressure data
