SECOND AMENDED AGREED COMPLIANCE ORDER

Pursuant to Ordering Paragraph 3 of Agreed Compliance Order 108, as amended by Amended Agreed Compliance Order 108-A, the Director of the Oil Conservation Division (OCD) hereby amends that order as follows:

FINDINGS

- 1. Agreed Compliance Order 108 (ACOI 108) as amended by Amended Agreed Compliance Order 108-A (ACOI 108-A) requires Yates Petroleum Corporation (Operator) to return to compliance with OCD Rule 201 at least 18 of the wells identified in Exhibit A by August 10, 2006, and file a compliance report by that date.
- 2. ACOI 108 further provides that if Operator returns to compliance with OCD Rule 201 at least 18 of the wells identified in Exhibit A by August 10, 2006, and files a timely compliance report, upon verification of the report the OCD shall issue an amendment extending the terms of ACOI-108 for an additional six-month period, requiring Operator to return an additional 18 wells to compliance by that deadline. If Operator exceeds its compliance goal in any period, the excess wells shall count towards its compliance goal for the subsequent period(s).
- 3. Operator filed a timely compliance report, and the OCD has verified that Operator has returned the following wells identified in Exhibit A to compliance:

CONCLUSIONS

- 1. Operator has returned 25 wells identified on Exhibit A to compliance, exceeding its 18-well goal by 7 wells.
- 2. The OCD should amend ACOI-108 to extend its terms through February 10, 2007.

ORDER

- 1. Operator shall return to compliance by February 10, 2007 at least 11 of the wells identified in Exhibit A to ACOI 108 as amended by ACOI 108-A not listed in Findings Paragraph 3, above, to meet its 18-well goal for this period.
- 2. Operator shall file a compliance report as described in ACOI-108 by February 10, 2007 using the Oil Conservation Division's web-based on-line application.
- 3. The terms of ACOI-108 as amended by ACOI 108-A otherwise remain in effect and are extended through February 10, 2007.
