Dear Mr. Franco:

Reference is made to the following: (i) your initial application (*administrative application reference No. pTDS0-613549697*) dated May 10, 2006; (ii) the New Mexico Oil Conservation Division's ("Division") response by letter from Mr. Michael E. Stogner, Staff Engineer in Santa Fe, New Mexico, denying this application; (iii) your re-submittal of this application (*administrative application reference No. pTDS0-617258708*) on June 21, 2006; (iv) Ms. Celeste G. Dale's, Regulatory Specialist with ConocoPhillips Company in Odessa, Texas, e-mail to Mr. Stogner on Thursday, August 31, 2006 checking on the status of this application; and (v) the Division's records in Hobbs and Santa Fe, including the file on Division Administrative Order NSP-1797-A (L): all concerning ConocoPhillips Company's request for a non-standard 75.02-acre gas spacing unit comprising the following acreage in the Eumont Gas Pool (76480):

## LEA COUNTY, NEW MEXICO TOWNSHIP 21 SOUTH, RANGE 36 EAST, NMPM

Section 30: Lot 1 and the NE/4 NW/4 (N/2 NW/4 equivalent).

This application has been duly filed under the provisions of the "Special Pool Rules for the Jalmat Gas Pool," as promulgated by Division Order No. R-8170-P, issued in Case No. 12563 on December 14, 2001.

This unit is to be dedicated to ConocoPhillips Company's existing Lockhart "A-30" Well No. 7 (**API No. 30-025-04838**), located at a standard Eumont gas well location 660 feet from the North and West lines (Lot 1/Unit D) of Section 30.

By the authority granted me under the provisions of Rules 4 (C), and 4 (D) of the special rules governing the Eumont Gas Pool, the above-described 75.02-acre gas spacing unit for the Lockhart "A-30" Well No. 7 is hereby approved.

Jurisdiction of this cause is retained for the entry of such further orders as the Division deems necessary.
