Mirage Energy, Inc. performed an acid job on well #1 that prompted an increase in oil production. Initial tests reduced the GOR limit to 36,000. The increase in oil production caused the well to reclassify to an oil well playing it in the Eumont Yates Seven Rivers Queen Oil pool. Therefore, your approval is required in order to split the 80 acres to two (2) 40 acre tracts as indicated on the attached C-102 Dedication Plats. Please note that there was no change to the Division of Interest in the well(s).


