1.0 INTRODUCTION

The Key Energy Services, Inc. (Key) Atha Well # 1 release site is located approximately 9 miles west of Eunice, New Mexico on Lea County Road 8. The release occurred on June 19, 2006. The New Mexico Oil Conservation Division (NMOCD) Form C-141 was completed and filed with the Hobbs, New Mexico NMOCD office on June 20, 2006 by Key personnel. The release site is located on property owned by the DASCO Cattle Company, Eunice, NM.

The cause of the release of approximately 200 barrels of produced water (initially reported as one to 1.5 barrels) was reportedly due to a hole in a storage tank that is associated with the salt water disposal system onsite. The initial surface migration of the release was across the caliche location pad to the west approximately 230 feet, then south approximately 178 feet. The surface flow of produced water continued south, into the surrounding pasture land, impacting an area approximately one to three feet wide by 300 feet long before pooling in an area approximately 140 feet wide by 40 feet long.

1.1 Site Description

General Site Description	The area of concern is a caliche pad on the north side of the storage tanks. The impacted area extends west and south down the caliche pad and into the pasture land. The surrounding area is an active oil field.

A topographic map (Figure 1) and a site map (Figure 2) are included in Appendix A.

1.2 Scope of Services

The proposed scope of work was to provide remedial efforts to satisfy the NMOCD requirements. The scope of work of the remedial efforts included:

- Excavation of the chloride-impacted soils near the surface (0-5 feet bgs) above the NMOCD approved cleanup level of <1,000 mg/kg;
- Subdivision of the excavated areas into 8 sampling areas and collection of confirmation samples to determine adherence to approved cleanup standards for chlorides of <1,000 mg/kg. Based on laboratory results, additional excavation, as required, of areas exceeding 1,000 mg/kg chlorides was performed;
- The disposal of excavated soil at a NMOCD approved landfill under manifest; and
- Backfill and site restoration of the excavation using backfill soil and caliche subsequent to compaction.

1.3 Regulatory Framework

As previously reported by Mr. Wayne Price, NMOCD, Santa Fe, NM, there are no published cleanup standards for chloride impacted soils in the state of New Mexico. However, Mr. Price has indicated that the standard NMOCD guidelines for remediation of chloride impacted soils is <1,000 mg/kg. Such efforts would be acceptable in the state of New Mexico to provide groundwater protection and remediate the site to the satisfaction of the NMOCD.

The web site for the New Mexico Office of the State Engineer was utilized to research the average depth to groundwater in Lea County, Section 31, T21S, R36E, and Section 6, T22S, R36E. The nearest recordable groundwater appears to be in excess of one half mile away, to the south in Section 31, T21S, and Section 6, T22S. The recordable groundwater depths for these wells appear to range from 195 to 212 feet below ground surface (bgs).

2.0 FIELD ACTIVITIES

2.1 Site Investigation

On June 19, 2006, a Terracon Project manager met onsite w/ Key Energy Services personnel for an initial site investigation. Key personnel indicated that verbal notification of the release had been made to the NMOCD and that NMOCD Form C-141 was being delivered the following day. The reported spill involved produced water from a storage tank onsite that flowed across the location caliche pad in widths ranging from one to eight feet. The release point on the tank was approximately one half inch in diameter and approximately 18 inches above the bottom of the tank. The flow path continued off the location pad into the surrounding pasture, impacting an area of

approximately one to two feet wide by 300 feet long before pooling in an area approximately 140 feet wide by 40 feet long. Under the direction of Key Energy, the decision was made to begin excavation of the impacted soil immediately to minimize vertical migration. RWI, Inc. of Hobbs, NM placed a One-Call for excavation on June 20, 2006 and subsequent excavation of the impacted surface soils was scheduled to commence on June 22, 2006.

On June 20, 2006, a hand auger was utilized to advance four soil borings to approximate depths of three to four feet bgs in the pasture land. Two of the soil borings were in the flow path and two of the soil borings were in the pooled area. The laboratory results from these soil borings indicated chloride concentrations ranging from 278 mg/kg to 4,110 mg/kg. No soil borings were advanced in the caliche soil on the location pad.

2.2 Soil Excavation

Excavation of the impacted soils began on June 22, 2006 using a backhoe and front-end loader. Based on the laboratory results from the hand augered soil samples collected in the pasture land, at depths ranging from 36 to 48 inches bgs, excavation of brine-impacted soil continued down to the caliche layer, with terminus depths from approximately 48 to 60 inches bgs. Confirmation soil samples were collected and submitted to Environmental Lab of Texas (ELOT) for analysis of chlorides using EPA method 300.0. The excavated areas in the pasture land are noted as sample points BH-1 through BH-5 on the site plan. The laboratory results indicated chloride concentrations of 3,530 mg/kg and 3,030 mg/kg in the areas of BH-1 and BH-5. Chloride concentrations in soil samples collected from B-2, B-3, and B-4 were below 1,000 mg/kg. Based on these results, excavation of brine impacted soil continued in the area of sample points BH-1 and BH-5 to a terminus depth of approximately seven feet bgs. Confirmation samples were collected, labeled BH-1b and BH-5b and submitted to ELOT for analysis of chlorides. Based on the laboratory results indicating chloride concentrations for BH-1b and BH-5b of 106 mg/kg and 510 mg/kg, excavation of the pasture land soils was terminated.

The initial excavation of impacted caliche soil on the location pad ranged in depths of approximately 12 to 18 inches bgs. Confirmation soil samples were collected and submitted to ELOT for analysis of chlorides using EPA method 300.0. The excavated areas on the location pad are noted as sample points BH-6 through BH-8 on the site plan. The laboratory results indicated chloride concentrations of 1,660 mg/kg and 1,460 mg/kg detected in the soil samples collected from BH-6 and BH-7. The chloride concentration in the soil sample collected from B-8 was below 1,000 mg/kg. Based on these results, excavation of brine impacted soil continued in the area of sample points BH-6 and BH-7 a terminus depth of approximately nine feet bgs. Confirmation soil samples were collected, labeled BH-6b and BH-7b and submitted to ELOT for analysis of chlorides. The laboratory results indicated chloride concentrations for BH-6b of 1,320 mg/kg and BH-7b of 1,190

mg/kg, which slightly exceeded the NMOCD cleanup level of <1,000 mg/kg chlorides. Based on these laboratory results, a call was placed to Mr. Wayne Price, NMOCD, Santa Fe, NM, to request termination of excavation activities on the location pad at sample points BH-6 and BH-7. Based on Key Energy's immediate initiation of remedial activities, groundwater depths exceeding 175 feet bgs, and declining chloride concentrations with depth, Mr. Price approved the termination of excavation activities on July 21, 2006.

2.3 Soil Remediation

The excavated topsoil from the pasture land and the caliche soil from the location pad were transported to Sundance Disposal facility in Eunice, Lea County, NM for disposition. Approximately 1,148 cubic yards of soil were transported to the disposal facility using 14 and 20 cubic yard dump trucks from RWI, Inc. Copies of the manifest tickets from Sundance Disposal are provided in Appendix D.

2.4 Soil Sampling

Terracon's soil sampling program included the collection of 16 soil samples. Four investigative soil samples, labeled as SB-1 through SB-4, were collected from the pasture land. Twelve (12) confirmation soil samples were collected from the excavated areas labeled BH-1 through BH-8. An additional four confirmation soil samples were collected from the over excavated areas labeled BH-1b, BH-5b, BH-6b, and BH-7b. The soil samples were analyzed for chlorides using EPA method 300.0.

The soil samples collected were placed in laboratory prepared glassware and placed on ice in a cooler. The samples and completed chain-of-custody forms were relinquished to Environmental Lab of Texas in Odessa, Texas for analysis. The executed chain-of-custody forms and laboratory data sheets are provided in Appendix B.

2.4 Site Restoration

Approximately 930 cubic yards of ambient topsoil and approximately 756 cubic yards of caliche soil were used for backfill and site restoration activities. The soil used for site restoration activities was obtained from the landowner, DASCO Cattle Co., Eunice, NM. This material was transported to the site using dump trucks, spread in four to six inch lifts, and compacted using heavy equipment. The excavated areas in the pasture land was restored, as near as possible to the natural grade of the surrounding landscape. The caliche pad material was leveled and compacted in six inch lifts and slightly rounded to provide adequate migration of surface waters during precipitation events. A retaining wall, approximately three feet in height, was constructed around the perimeter of the

location pad using caliche soil to prevent future releases from migrating off site. Photographs documenting the remediation activities and final site restoration are included in Appendix C.

3.0 DATA EVALUATION

Confirmation soil samples of the impacted areas were collected during the excavation activities. Analytical results of the soil samples were compared to the NMOCD target cleanup level of <1,000 mg/kg chlorides. The laboratory results indicate final chloride concentrations in the pasture land excavation (BH-1 through BH-5) range from 89.1 mg/kg to 791 mg/kg. The laboratory results indicate final chloride concentrations in the caliche pad excavation (BH-6 through BH-8) range from 595 mg/kg to 1,320 mg/kg. Subsequent to approval from Mr. Wayne Price, NMOCD, the limited area exhibiting chloride concentrations slightly exceeding the NMOCD 1,000 mg/kg guideline were left in place.

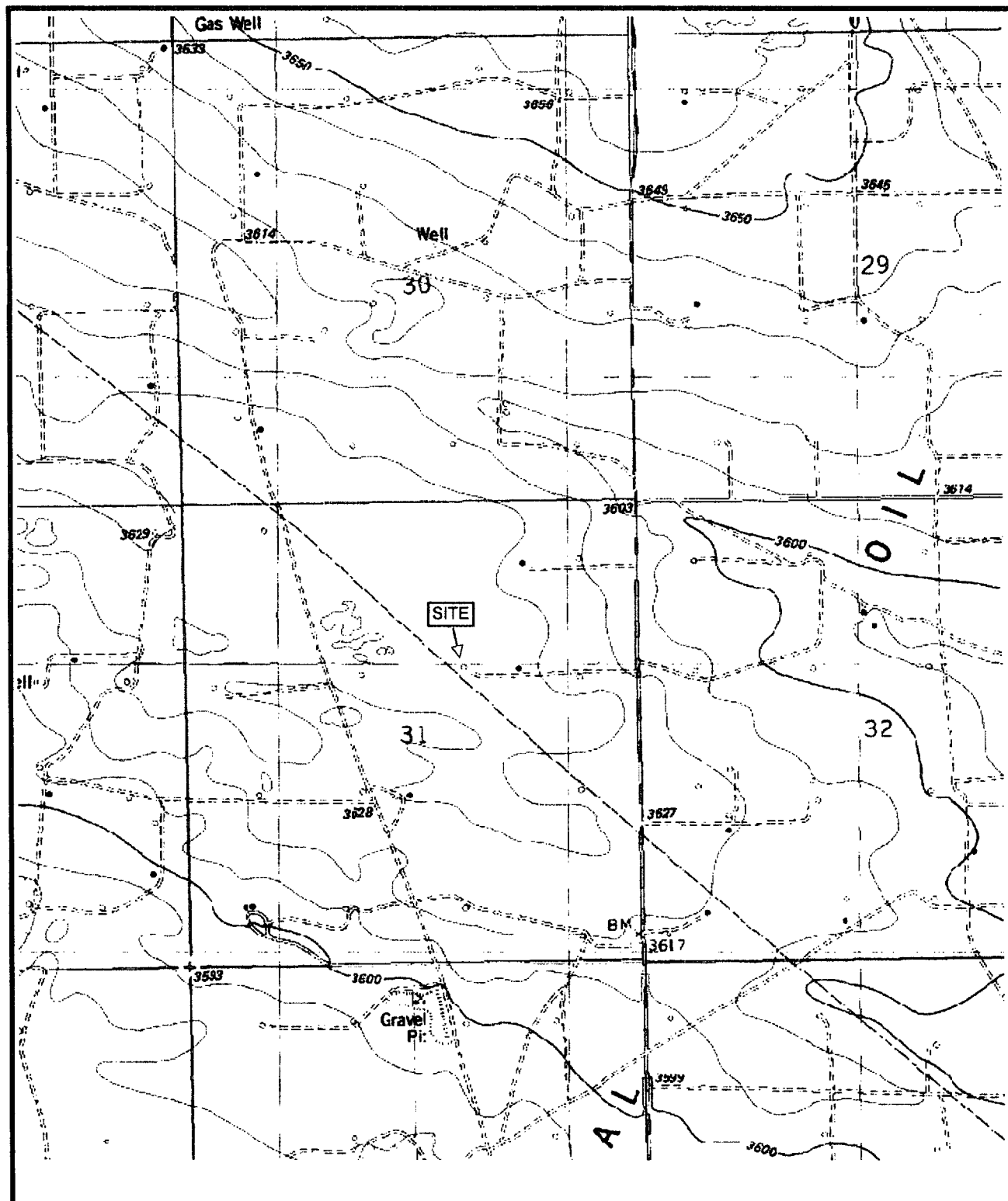
4.0 FINDINGS AND RECOMMENDATIONS

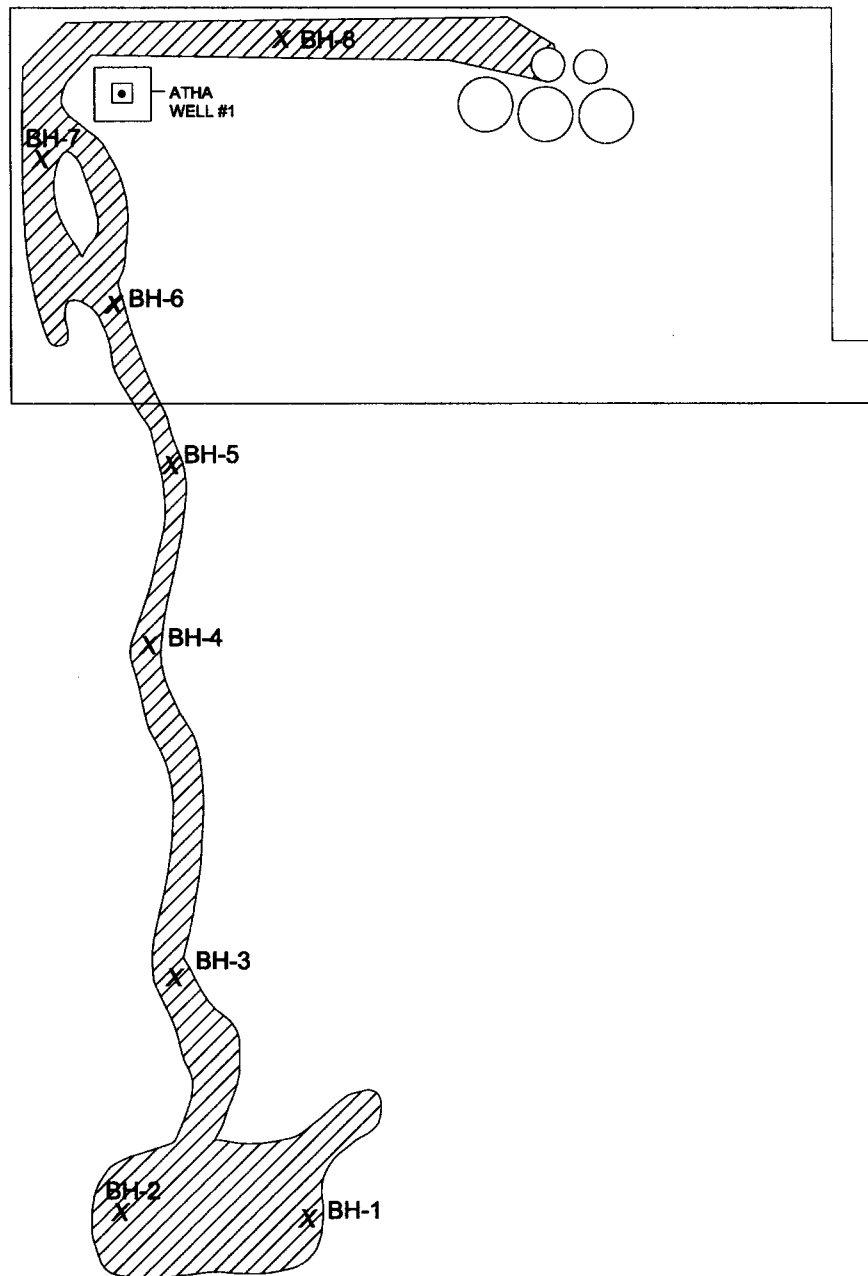

FIGURE 1: TOPOGRAPHIC MAP

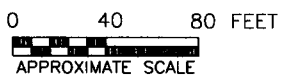

Dan, please review this email correspondence. I have been unable to contact Mr. Sheeley on either his cell phone or office phone. I have left messages, but they have not been returned.

Mr. Sheeley,

On behalf of Dan Gibson, at Key Energy, I am writing to inform you as to the status of the Atha Well #1 SWD. With the exception of two soil samples, the chloride results are below 1,000 ppm. Two soil samples collected at 9' in depth on the location pad, contained concentrations of total chlorides at 1,320 ppm and 1,190 ppm. These results were a decrease from samples taken at the five foot interval, which were 1,660 ppm, and 1,460 ppm.

The chloride impact as a result of off-site migration into the adjacent range land has been removed and backfilled with clean material.

Prior to performing any additional work, are these sample results low enough to satisfy the NMOCD, based on the decreasing concentrations with depth, the sample locations, and in lieu of the remedial efforts that have been performed to date.

With your approval, we are prepared to backfill the remaining two excavations (at the locations of the two soil samples) and return the site to pre-spill conditions.
