Dear Ms. Wrotenbery and Mr. Spencer:

Texakoma Oil & Gas Corporation requests approval to downhole commingle the production from the Flora Vista Fruitland Sand formation with that of the Basin Fruitland Coal formation in its Texakoma Federal 7 #1 well located 1785' FNL, 1675' FEL, G-7-30N-12W, San Juan County, New Mexico. These same two pools were commingled downhole in Texakoma's Federal 8 #2 well, which was recompleted August 2, 1999. (Please refer to Order DHC-2311 dated April 22, 1999.)

The ownership is common throughout the lease, NM-047, dedicated to the well.

Enclosed is NMOCD Form C-107-A with attachments.

We request that the allocation of production be assigned after the well is completed in accordance with the District Supervisor in Aztec. As was done in Texakoma's Federal 8 #2 well, we request using a third-party reserve determination as a basis for calculating the allocation formula.

The only offset drill tracts for either of the subject zones is Texakoma's Federal 8 #2 and Federal 8 #1 wells.

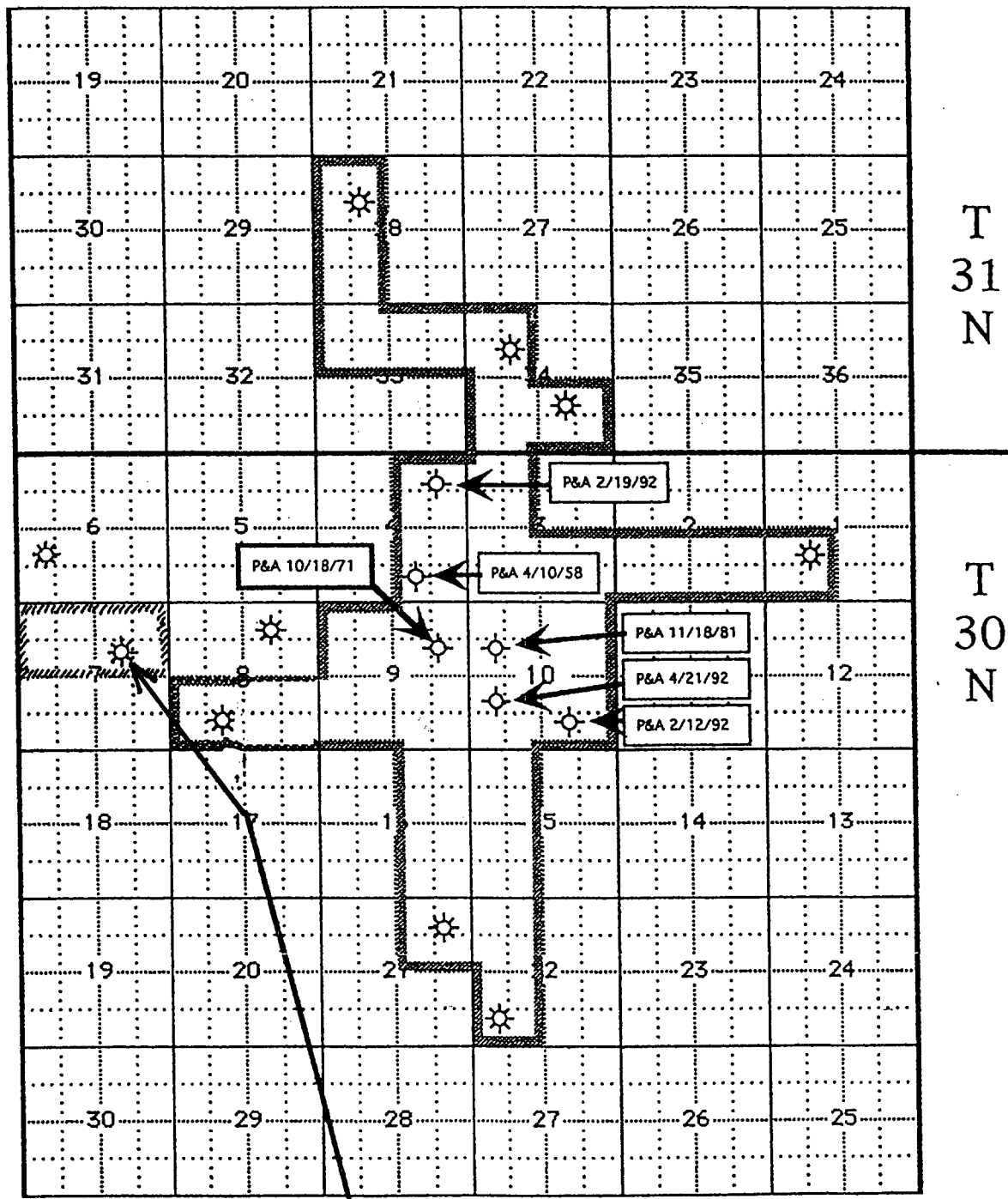

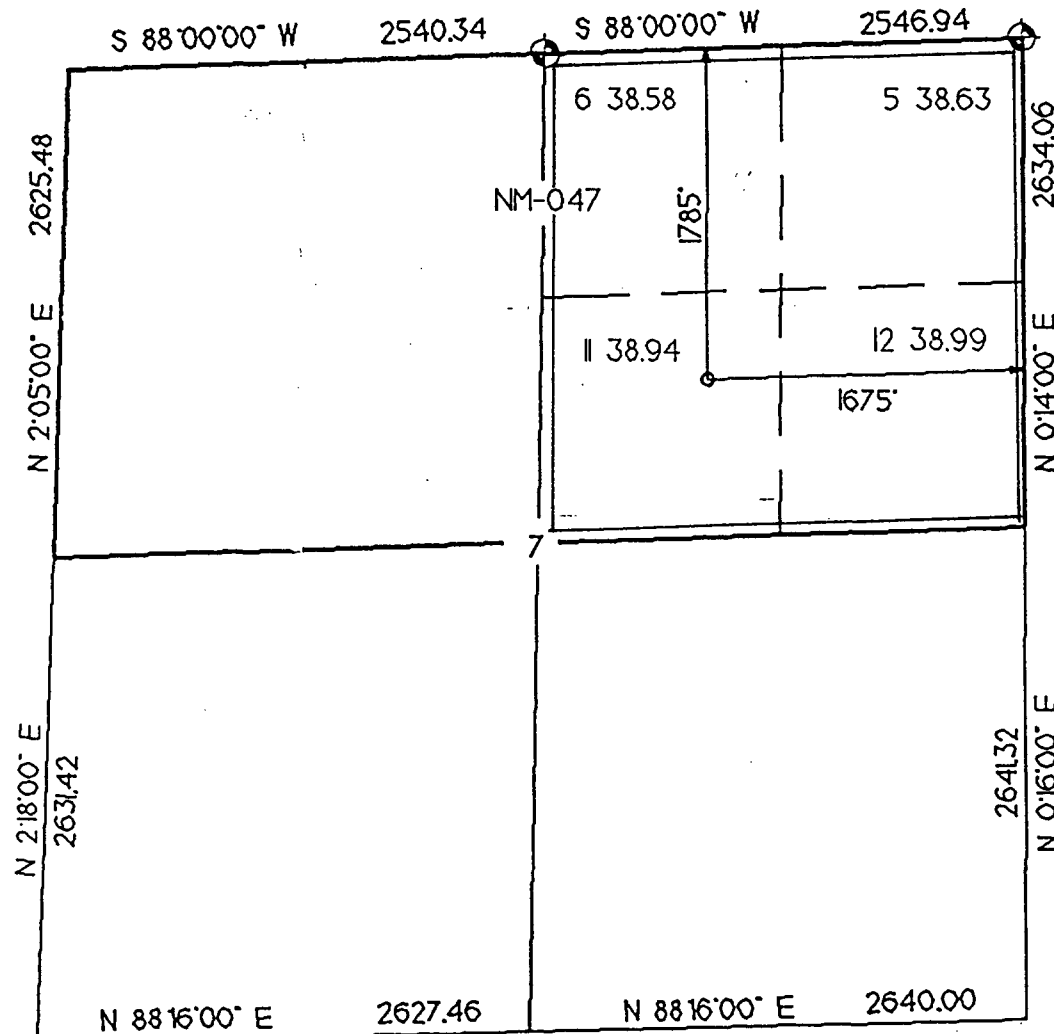

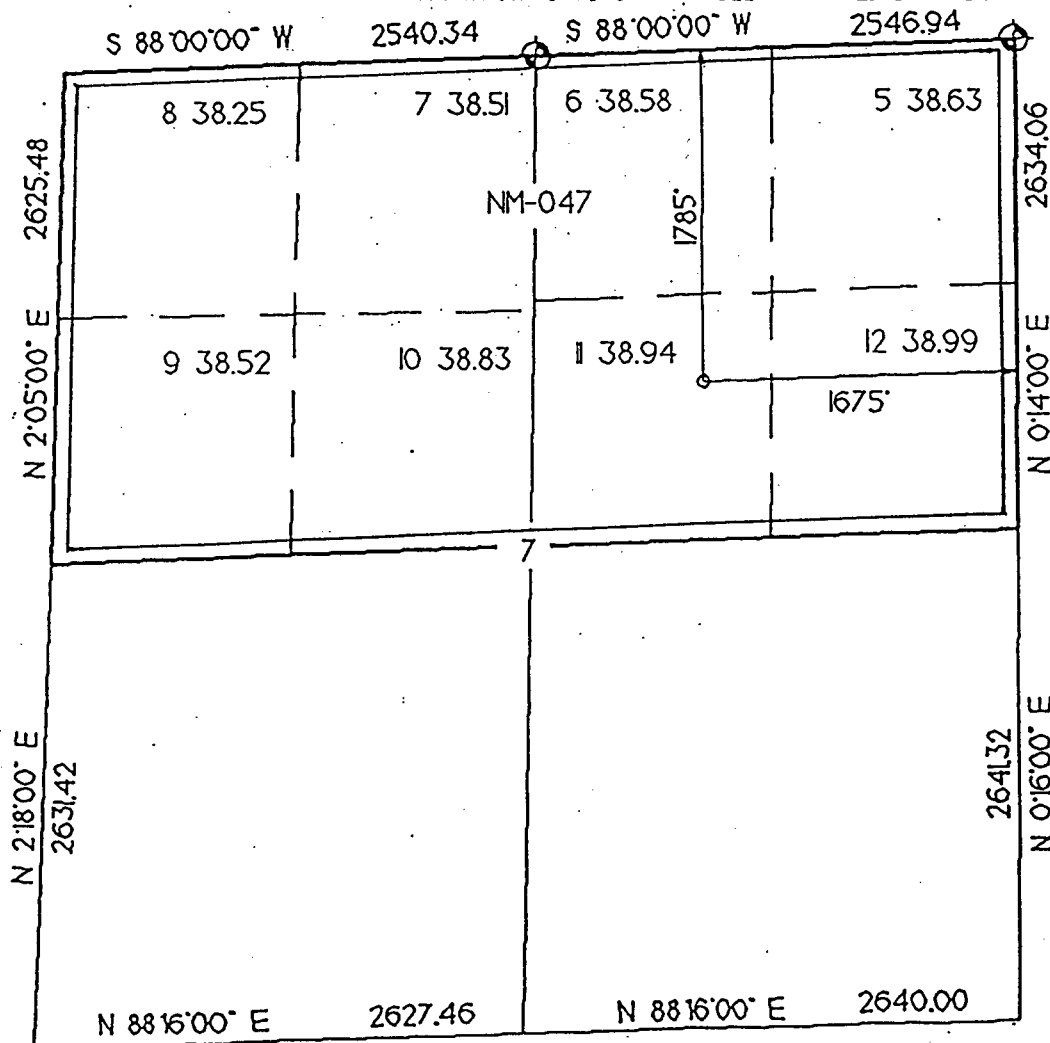
