Your application requests our approval to downhole commingle the Artesia, Queen, Grayburg, San Andres and Artesia, Glorieta, Yeso production within the wellbore of the "D" State Well Nos. 1, 7, 8, 9 and 10 located in, Sections 25, 26, 35 and 36-17S-28E, Eddy County, New Mexico.

It is our understanding that production from the subject wells will be allocated as follows:


