- a) **Production Allocation---How is the production going to be allocated to each of the commingled zones and, is the Blanco-Mesaverde going to be production tested prior to commingling.**

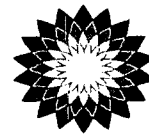
Since the submitted information is insufficient to review, the application was **Ruled Incomplete** on July 26, 2001. Please submit the above stated information by August 2, 2001.

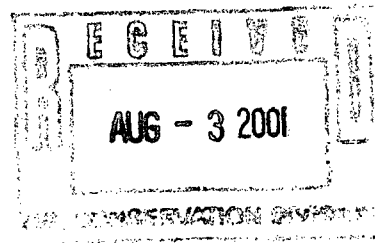

Reference your letter dated July 26, 2001

Production is proposed to be allocated based on the subtraction method using the future projection of production from the BS Mesa Gallup and the Basin Dakota. That production shall serve as a base for production subtracted from total production for the commingled well. The balance of the production will be attributed to the Blanco Mesaverde. The Blanco Mesaverde will be production tested prior to down hole commingling.
