Your application to downhole commingle the production from within the wellbore of the above-captioned well was received on January 23, 2001. Your application requests our approval to downhole commingle the Foor Ranch (Wolfcamp) and Foor Ranch (Cisco) production within the wellbore of the Witz "VN" State Well No. 2 located in Unit Letter A, Section 26-09S-26E, Chaves County, New Mexico.

It is our understanding that production from the subject well will be allocated as follows:


