We have studied these records and find no evidence of any incompatibility. This is to say that based on the evidence we have available, we would not expect any precipitation or scaling potential to result from combining Bone Spring and Wolfcamp based on our records in this area.

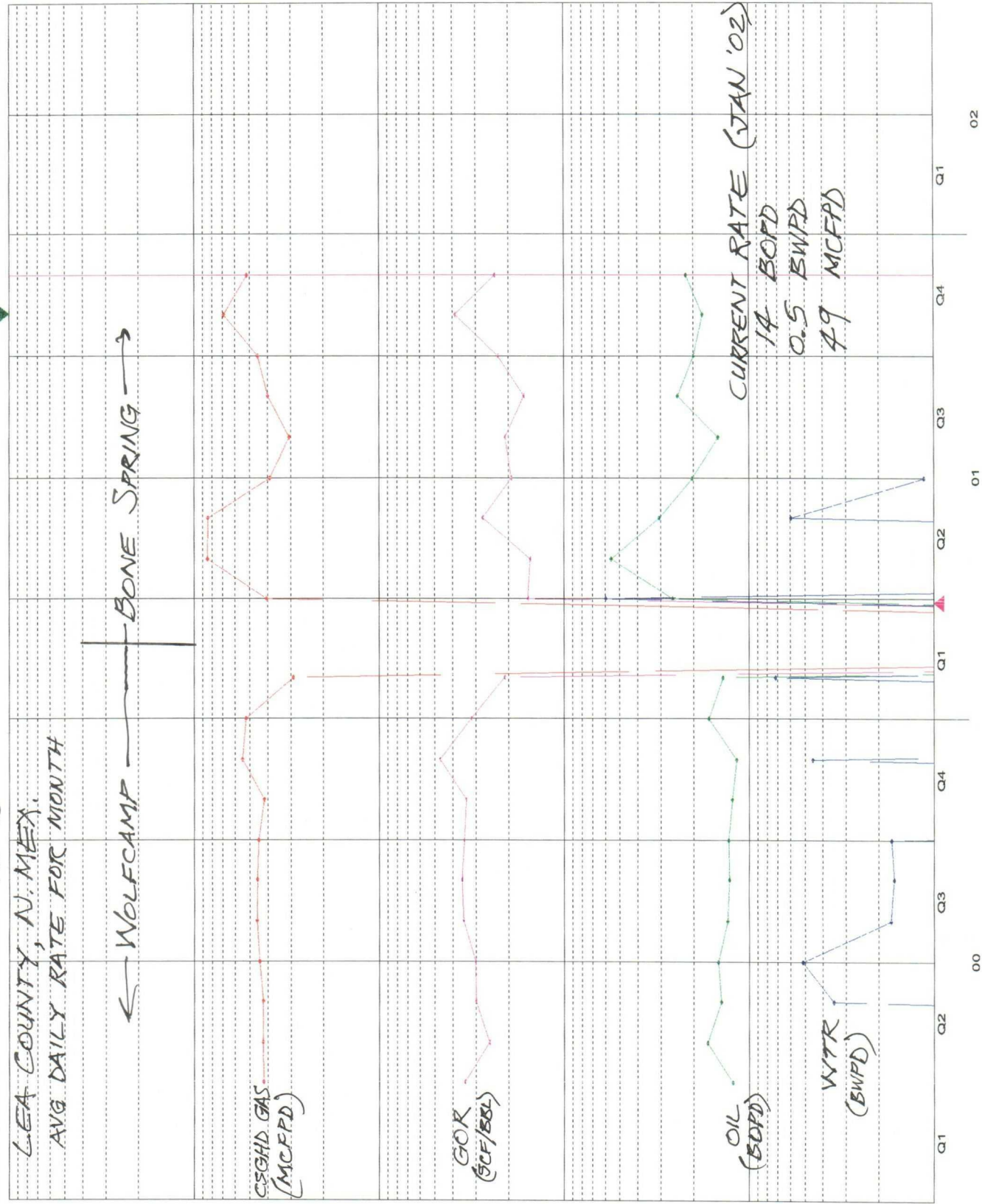

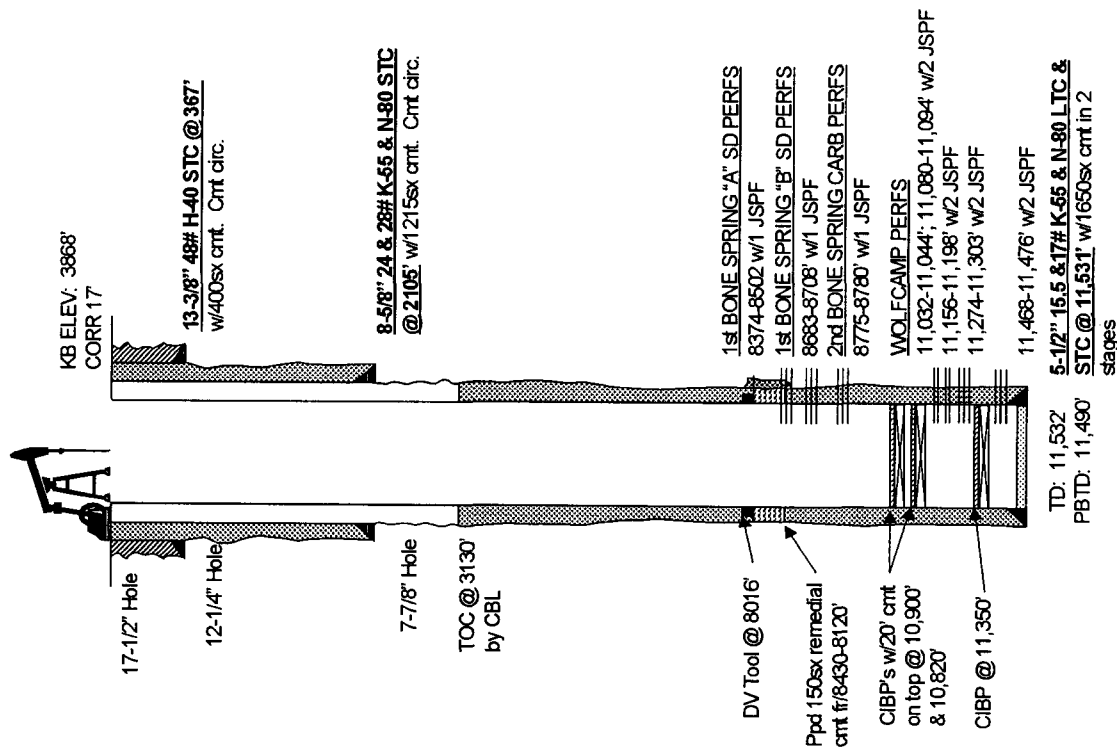
