Your application to downhole commingle the Dagger Draw Upper Penn, South, Indian Basin Strawn, North and Wildcat (Atoka) production from within the wellbore of the above-captioned well was received on September 13, 2002.

Since it appears that all the New Mexico Oil Conservation Division's rules and regulations have been complied with, and there will be no loss of revenue to the State of New Mexico as a result of your proposed operation, your request for downhole commingling is hereby approved. 
