M & G Drilling Company, Inc. requests administrative approval for a non-standard gas well location in the Basin Fruitland Coal pool for its Schlosser 34 No. 102S well.

The Schlosser 34 No. 102S, a W/2 dedication, was staked in an unorthodox location due to extremely rough topography as shown on the enclosed topographic map. In order to place the well in an accessible location, the well was staked 495' FWL, encroaching 165' west of the standard drilling window. M & G Drilling Company, Inc. is also the leaseholder of Basin Fruitland Coal rights in Section 33 of Township 28 North, Range 11 West, thus the location only impacts M & G Basin Fruitland Coal rights and no offset owners are affected.

Please find enclosed a C102 plat showing the location of the well, a topographic map, and a map showing that no offset owners are affected by the unorthodox location.


