This is to ask your permission to drill the Mesa Retailers, Inc., State #2, in Unit B, which I desire to drill 430 feet from the North Line and 2010 feet from the East Line in Section 36-16S-26E, due to the following condition:

9000' test.

A center of the 40 location will create an undue hardship and expense because of the fact that said location would fall on a tract of land that is cultivated and under irrigation. The footage set out above will cause the location to fall on a portion of the land not under cultivation and not under irrigation as it is in the edge of some lowlands which cannot be used other than for grazing. The location desired would thus create a very small amount of damage as compared to that which would be caused by staking same on the active farm land.

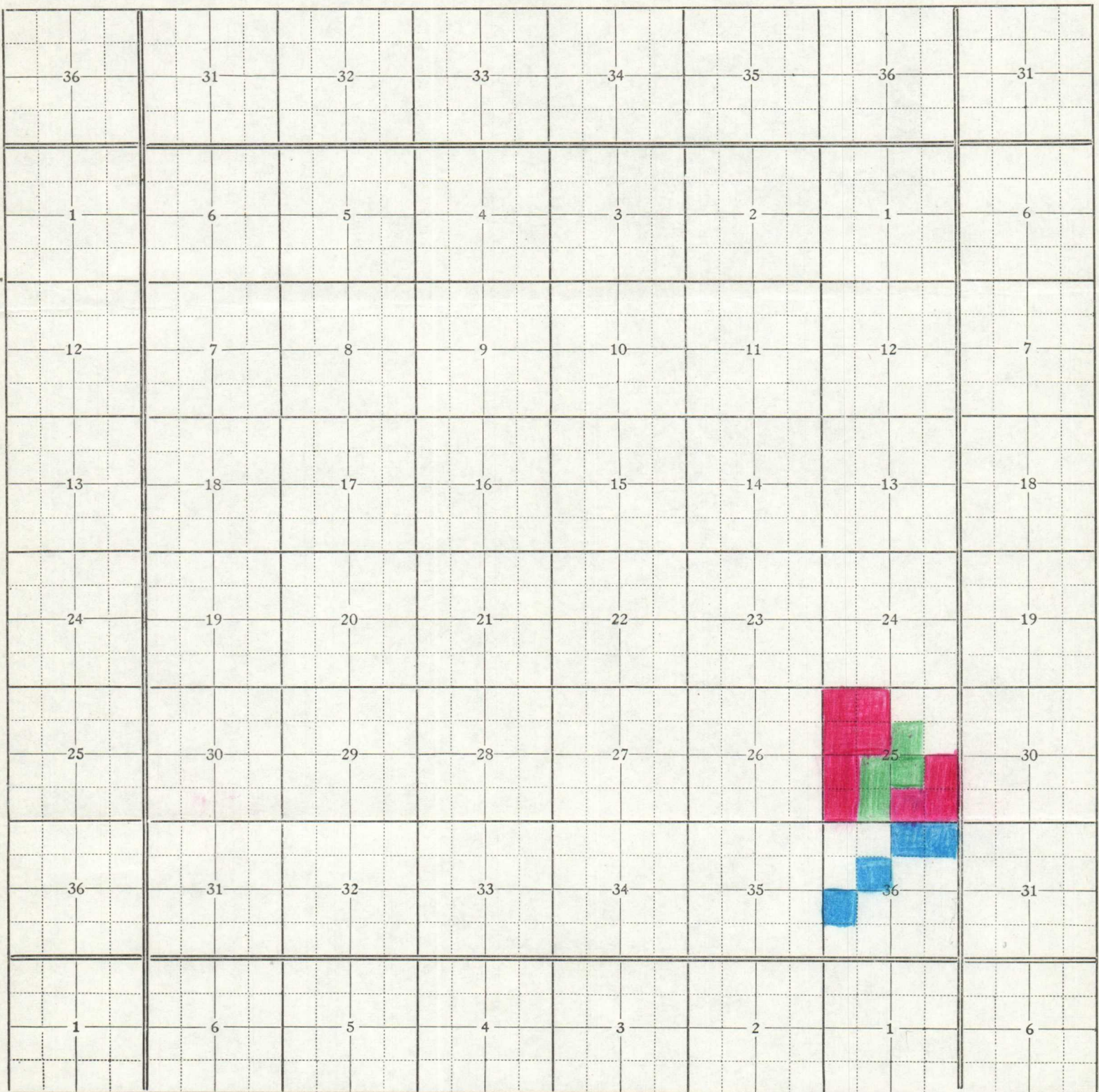
