Dear Mr. Porter:

This is to request administrative approval of an unorthodox location to be located in the South Blanco Extension Pictured Cliffs Reol, San Juan County, New Mexico.

This well, out Schwerdtfeger No. 7-A is to be located 680' from the South line and 852' from the East line of Section 31, Township 20 North, Range 8 West, N.M.P.M., San Juan County, New Mexico. The southeastern portion of this 1/4 section consists of the edge of a mesa with the remaining portion of the 1/4 section consisting of a high mesa bench and ridges with dry washes which would make the cost of roads and location extremely expensive.

The well is to be a Pictured Cliffs test and since EL Paso Natural Gas Company holds the lease in the NE/4 of Section 6, Township 27 North, Range 8 West the approval of other operators has not been sought.

I am enclosing two copies of the Certified Well Location . Plat sketching terrain conditions and two copies of our Intention to Drill.

Thank you for your attention to this matter.


