Humble Oil & Refining Company respectfully requests administrative approval of an unorthodox location for its Tanner Unit Well No. 1. This well is located 1010 feet from the South line and 970 feet from the West line of Section 21, Township 24 North, Range 12 West, San Juan County, New Mexico.

We support our application with the following statements:

1. The necessity for the unorthodox location is based on topographical conditions.
2. The ownership of all oil and gas leases within a radius of 790 feet of the location is common with the ownership of the oil and gas leases under the location.
3. All offset operators were notified by registered mail of our application for approval of this unorthodox location.

A Revised Form C-128 is attached hereto showing to the best of our knowledge the location of the well.

In view of the facts set out herein, it is respectfully requested that the Commission approve the unorthodox location of this well.

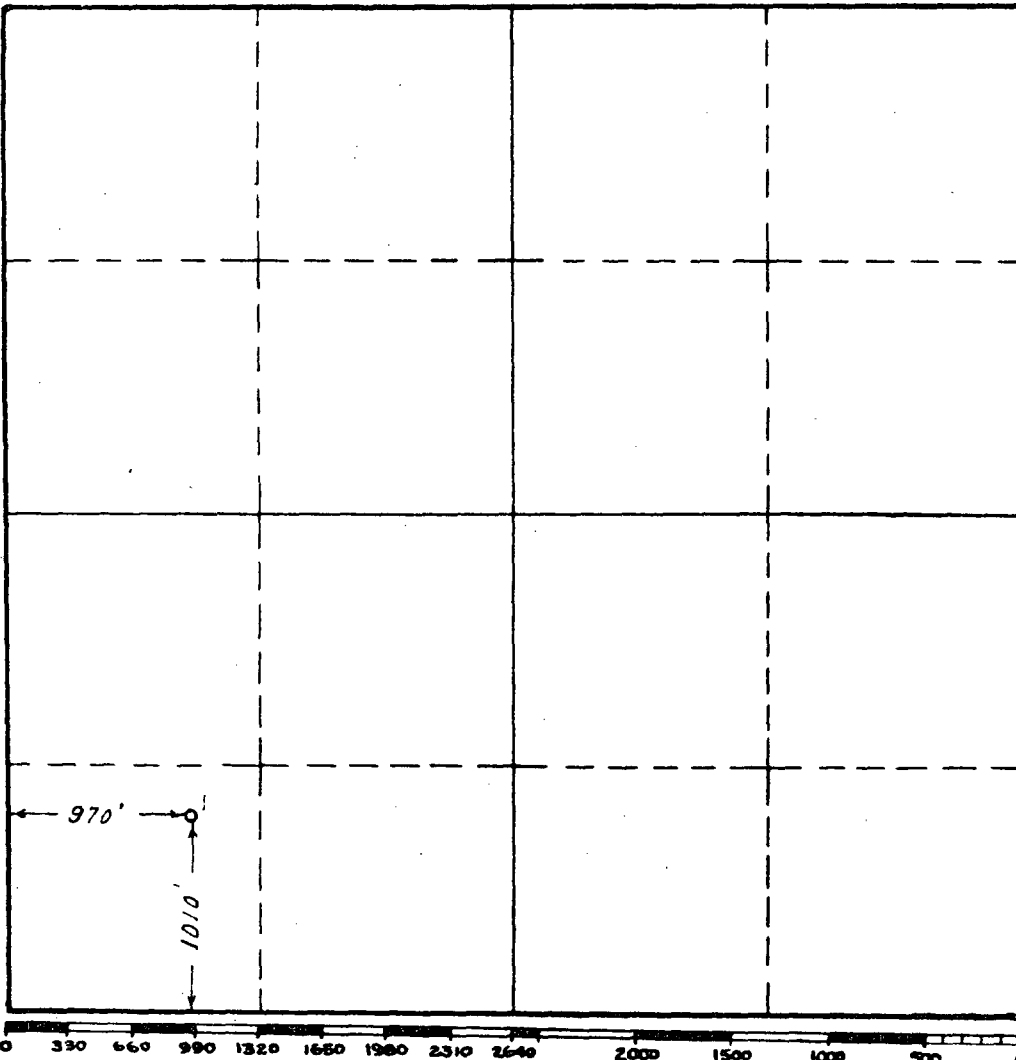
