Dear Mr. Porter:

As Operator of the Northeast Blanco Unit, we request permission to drill an unorthodox well, to be located 500' from the South line and 1970' from the West line of Section 27, T 31 N, R 7 W, San Juan County, New Mexico. We want to drill Well No. 60-27 on this location.

Because of the anticipated water level of the Navajo Dam Project and the rough terrain in and surrounding the normal location for this well, it is necessary to select a more appropriate drilling site.

Section 27-31N-7W is a part of the Northeast Blanco Unit and all leases within a 790' radius of the unorthodox location, as requested, is jointly controlled by the Northeast Blanco Unit participants.

We enclose a location plat of the requested location.

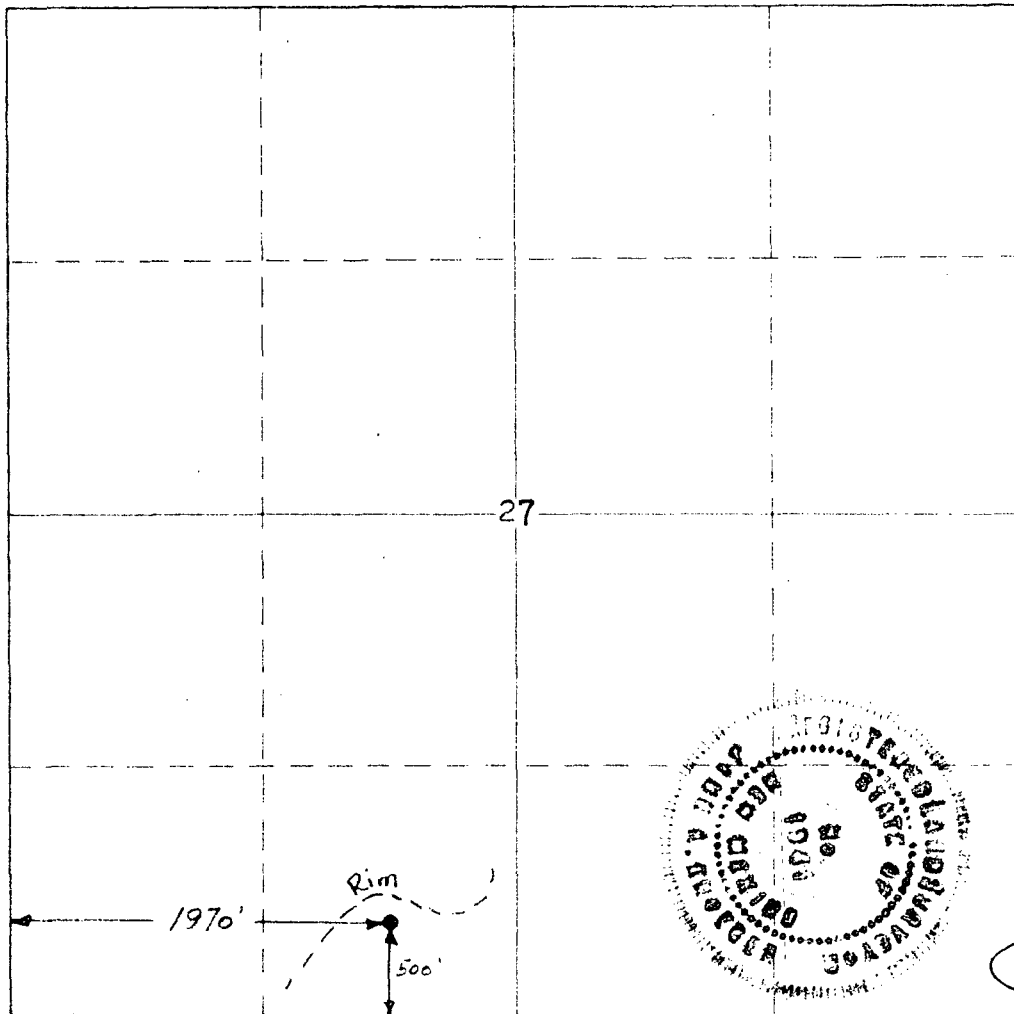
