Dear Sir:

Enclosed please find forms C-101 and C-128 covering a wild-cat well to be drilled in an unorthodox location in the SE $\frac{1}{4}$ of the SE $\frac{1}{4}$ of Section 18 Township 29 North in Range 13W NMPM.

We are also enclosing photostat of a telegram received to-day from the Texas Company who are the only off-set Owners less than 790 feet from the proposed well location.

Our request for an unorthodox location of 790 feet from the East line and 740 feet from the South line of Section 18, is based upon the topographical situation existing in this area. We have placed our location as close as possible to the orthodox 790 feet from the South line and are within 20 feet of the bank of the San Juan river. The only other possible location for a well would be on an island in the river, which would cause undue hardship and expense in reaching the location in order to drill the well, and upon having completed said well, if successful, the pipe line company would be forced to use an aerial suspension line to cross the river, which at this point is approximately 1500 feet wide, and during flood water conditions it would be practically impossible for anyone to reach the location to conduct the operations necessary in producing a gas well.

We feel under the circumstances, and in view of the fact that we have permission from the Texas Company as the only off-set operator within 790 feet, that we are justified in requesting per-

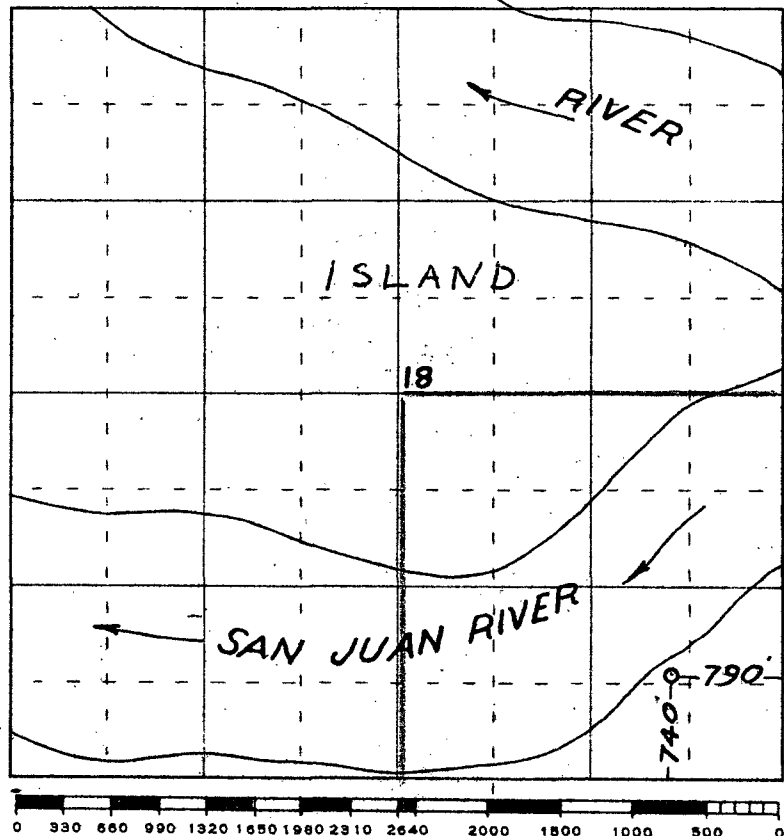

Note: All distances must be from outer boundaries of section.

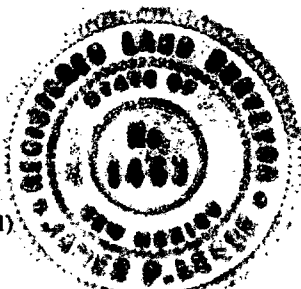
