Re: Permit to drill Hawaiian-New Mexico Oil Ventures #1, SW1 NW1, Sec. 27, T.7N., R.4W., Valencia County, New Mexico.

Gentlemen:

Hawaiian-New Mexico Oil Ventures, a Limited Partnership, respectfully requests permission to drill a well which is an exception to Rule 104 in the southwest quarter of the northwest quarter of section 27, township 7 north, range 4 west, Valencia County, New Mexico. This location as set out by survey is 51 feet east of the west line and 1530.5 feet south of the north line of the above described section.

A reason for the request of exception to Rule 104 has to do with the surface conditions which make locating the rig and pits elsewhere nearby impossible.

An additional reason for the request of exception to Rule 104 has to do with geological indications. As evidenced by the enclosed letter from Paul Blackman, record owner of the offset lease, it is the desire of those concerned to locate the requested location as close as practical to an old well drilled from 1925-1931 with cable tools which had gas shows. The indicated shows with todays methods of completion should make a commercial well. A commercial well in this area would be of material benefit to the State of New Mexico.

I hope, from my recent trip to see you that the enclosed forms and letters cover your requirements for a permit to drill the requested location.


Your earliest attention would be appreciated as arrangements have been completed for the commencement of this well.

Dear Mr. Buttram:

I am the record owner of a Federal Oil and Gas Lease covering among other lands, Section 26, Township 7 North, Range 4 West, Valencia County, New Mexico.

You have informed me that you are the owner of an Oil and Gas Lease covering among other lands Section 27. Township 7 North, Range 4 West, Valencia County, New Mexico; that you contemplate drilling a well in Section 27 and because of certain surface advantages you wish to drill the well 51 feet west of the East line and 1530 feet South of the North line of Section 27, Township 7 North, Range 4 West, Valencia County, New Mexico, instead of the usual location as prescribed in the spacing requirements of the Oil Conservation Commission of the State of New Mexico.
