Per our phone conversation on 12/6/06, due to NPC's success in plugging back from the Cisco to the Glorieta/ Yeso wells which are associated with CTB-459, we are requesting to amend the subject commingling order. NPC hereby requests administrative approval to Surface Commingling and Off Lease Measurement of the oil and gas production from the wells listed on Attachment I.

The common tank battery for said wells is located in Unit E, Sw/4 NW/4 of Section 22, T19S, R25E, Eddy County, New Mexico. The Cisco oil will be in the existing tanks and the Yeso oil will be surface commingled in two additional tanks. Attachment III will show the new layout of the battery and also states what wells are or will be producing out of which zone. The wells with an asterisk are wells that NPC is planning on plugging back to the Glorieta/ Yeso in the future.

All production will be metered separately from each well and the meters will be calibrated on a regular basis.
