We are in the process of communitizing the E/2 of Section 3, T31N-R13W, San Juan County, New Mexico for purposes of drilling a Mesa Verde test.

Attached is a survey plat denoting the location as now staked. At this location we are precariously close to the eastern edge of the LaPlata River. In order to resolve this problem, we request permission to move the location forty feet due east. This would then be an unorthodox location at 790 feet from the north line and 750 feet from the east line.
