Dear Dan:

It is our understanding that the Gulf Oil Corporation will request approval of a non-standard location for their Hackberry Hills Unit Well Number 7 in Section 7-22-26. On December 4, 1962, I inspected the site of the proposed location at the request of the operator to verify the necessity for the non-standard location. The attached plat shows the two main limiting topographic features consisting of a canyon and a rock knoll or ridge. Under normal circumstances one standard location would be possible, (330 feet from the north and west lines of the unit), however, the necessity for the removal of about 4 to 5 feet of solid rock would increase the cost of the location by 8 to 10 thousand dollars. Since the well is a wildcat and the acreage is all unitized state land I would recommend that the location, 150 FNL-2055.84 FEL, be approved when requested.

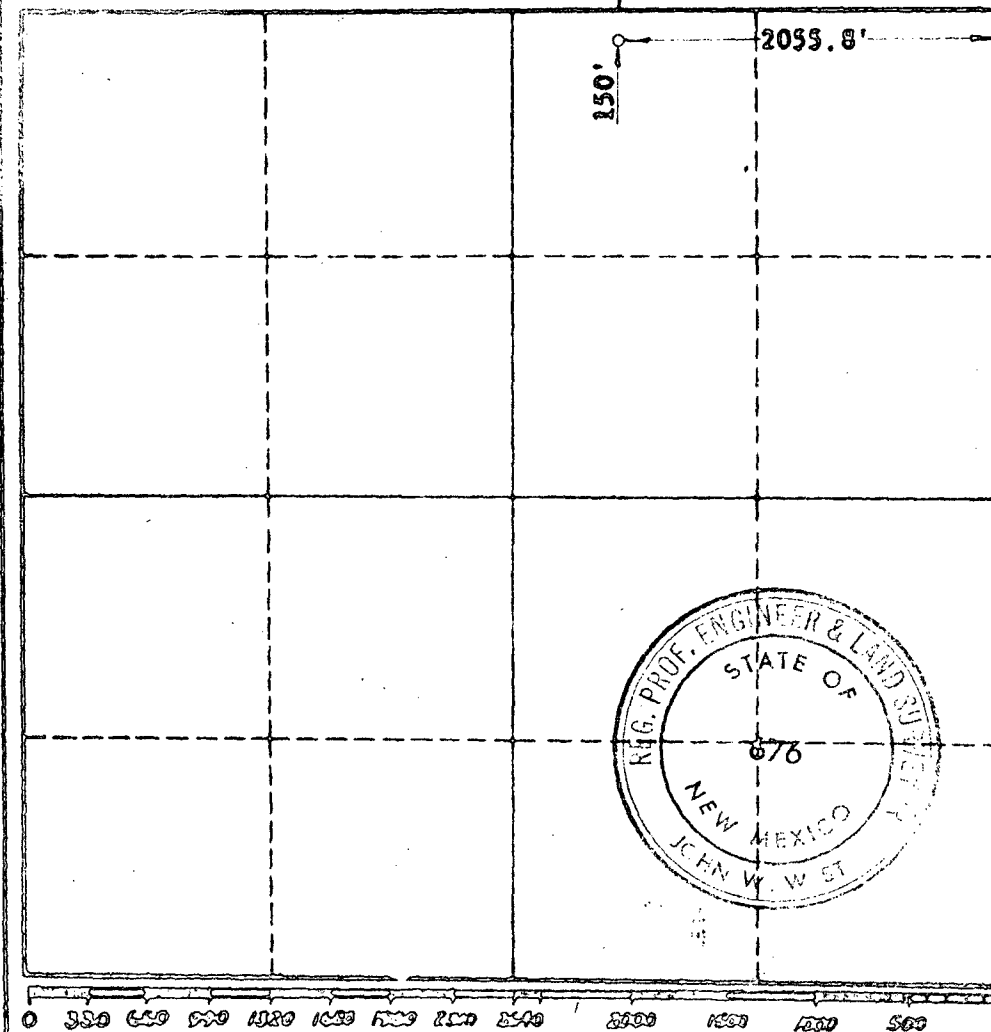

This is an unorthodox location. The property on which this well is located lies within the Hackberry Hills Unit, consisting of 13,920.38 acres, which was approved by both the State of New Mexico and the United States Geological Survey, with the approval dates being February 13, 1961 and February 27, 1961, respectively, and is surrounded by property within this Unit. It is necessary to drill the well at this location due to the rough terrain encountered on top of the mountain. This is the same base Unit and there are no offset operators involved.
