Please find enclosed a plat showing the proposed non-standard location for a Mesaverde and Dakota dual well in Section 5 Township 26 North, Range 4 West. We have been designated operator for the entire section and therefore no waivers are required from off set operators.

The standard location 1590 from the south line 1595 from the west line is located in a narrow box canyon that is almost impossible to build access roads into and would constitute undue hazards for gas drilling.

We would like to request administrative approval for this non standard location due to the drilling hazards and difficult problems that would be encountered in building roads and a suitable location.

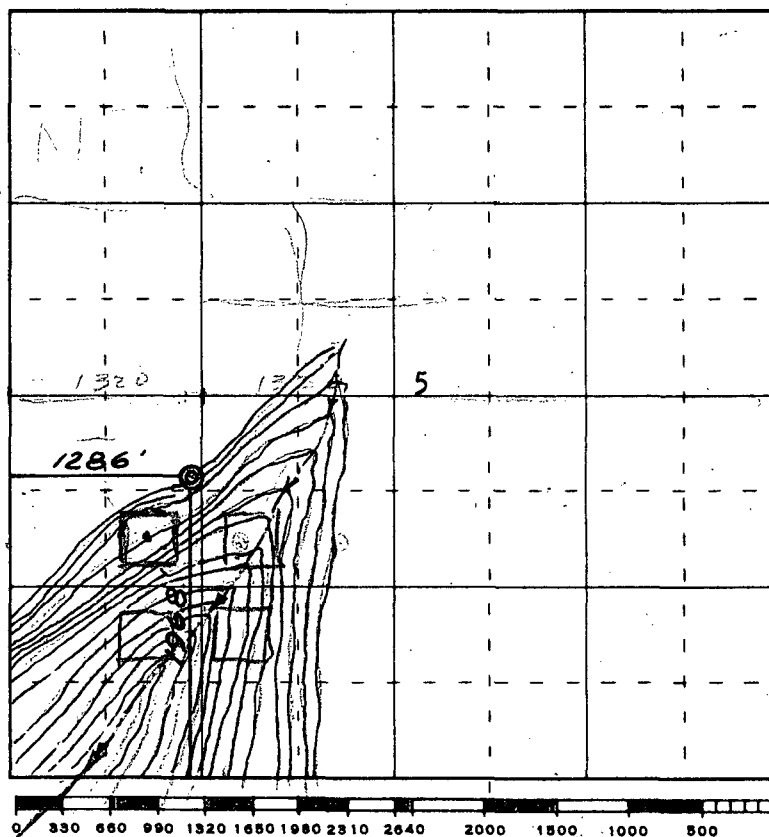
