I request that you permit me to drill at an unorthodox location because of unfavorable topographical conditons. I have been designated operator of all of Section 1-23N-1W, Rio Arriba County, New Mexico, and I desire to drill a 2500' wildcat test, to be known as the Skelly Federal #1, at the following location:


2355' from the south line and 1510' from the east line, Sec. 1-23N-1W
