Dear Mr. Porter

Pursuant to the Commission's Order No. R-1193, Rule 3(B), request is made for administrative approval to drill the captioned well at an unorthodox location 2140 feet from the North line and 1270 feet from the West line of Section 8, Township 26 North, Range 4 West, Rio Arriba County, New Mexico.

The reason for this request is that any location within the area required by Rule 3(A) for an orthodox location would be on a steep slope or at an elevation above 7100 feet and could be reached by the most convenient route from Farmington only by building an expensive road up the slope or by traveling over existing roads approximately five miles farther than would be necessary to reach the proposed location at an elevation of 6850 feet.

The ownership of all oil and gas leases within a radius of 790 feet of the proposed location is common with the ownership of the oil and gas lease under the proposed location.

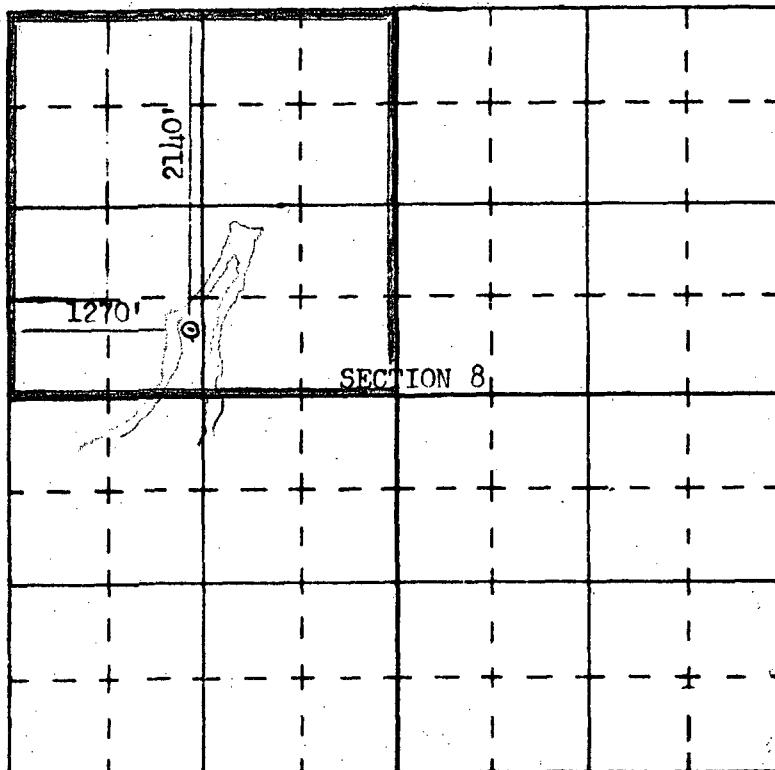
