Skelly Oil Company is hereby applying for approval to recomplete their Jicarilla "B" Well No. 3 in the Dakota formation between the depths of 6900' and 6938'.

The well designated was drilled to a total depth of 7139' with 5-1/2" casing set at 7123' in September, 1957. The Dakota formation was perforated from 6900' to 6938' and treated down tubing and annulus with 20,000# sand and 20,000 gallons of lease oil. The well was opened and flowed back 425 barrels of load oil in 33 hours through a 3/4" choke with a flowing tubing pressure of 90# and a flowing casing pressure of 400#. The gas measured 730 MCF per day.

Since the Gallup formation was considered more profitable at that time, a Baker cast iron bridge plug was set at 6780' and 2 sacks of cement spotted on top of the plug. The Gallup was then perforated from 5858' to 5952' and treated with 35,000# sand and 35,000 gallons of lease crude. The well produced from the Gallup until it was shut down February 1, 1965 and after reaching its economic limit.

Consideration is now being given to the recompletion of the well back to the Dakota formation. To do so will require the cement squeezing of the Gallup perforation, and the drilling out of the bridge plug at 6780'.


The Jicarilla "B" Well No. 3 is on a standard Gallup oil well location of 660 feet from the north line and 660 feet from the west line of Section 5. Normal Dakota locations are 790' from the respective boundaries of the proration unit.

Commission Order No. R-1670-C states that the Secretary - Director shall have the authority to grant administrative approval for an exception to Rule No. 104 without notice and hearing if the Secretary - Director determines that good cause exists for granting such exception and if the offset operators do not object.

A registered letter has been sent to Gulf Oil Corporation, P. O. Box 1938, Roswell, New Mexico, to the attention of the District Production Manager. Gulf is the only other operator offsetting the 320-acre proration unit. A copy of the registration receipt is attached.

Please review Skelly's application for permission to produce the Dakota formation from the Jicarilla "B" Well No. 3. If no objection is received within the specified period from the offset operator, and if the Commission has no objection, it is understood that permission will be granted.

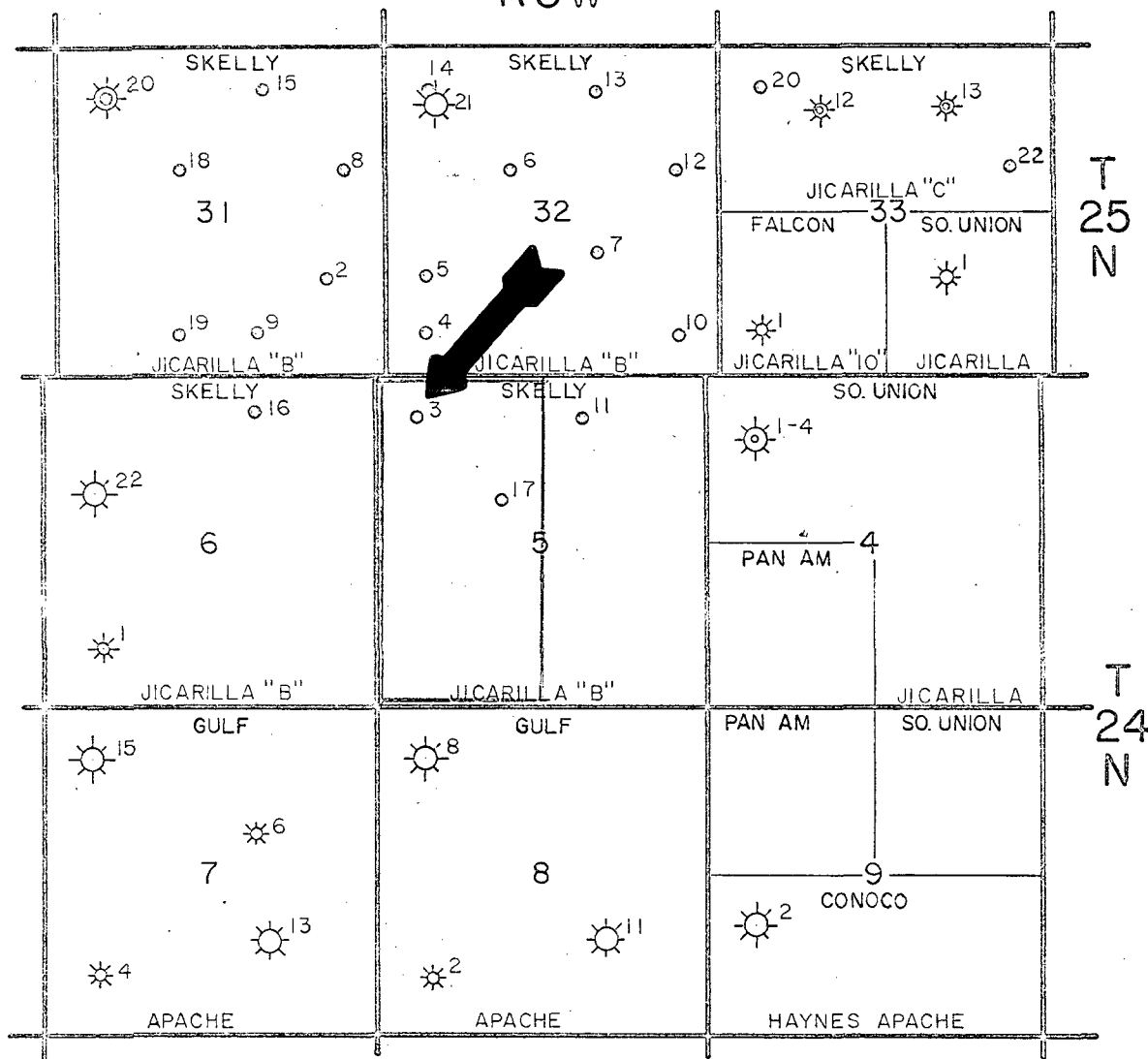
