On behalf of Ralph Nix and Charles Powell, I request administrative approval for an exception to the well location requirements of Rule 104 of the Oil Conservation Commission to permit the reentry into the plugged and abandoned Hirst Well located 2390 feet from the North line and 1050 feet from the West line of Section 17, Township 18 South, Range 28 East, N.M.P.M., Eddy County, New Mexico.
