

Gentlemen:

Shell Oil Company requests administrative approval for an unorthodox location for its McKinley A-11 in the Hobbs, Blinebry-Drinkard pool in Lea County, New Mexico under special rules for the Hobbs Drinkard field - Order No. R-3811 by the New Mexico Oil Conservation Commission. Attached is the required Form C-101 and certified plats. The proposed location is 1980 feet from the west line and 420 feet from the south line of Section 19, Township 18 South, Range 38 East, Lea County, New Mexico.

Administrative approval of this unorthodox location is requested as a special case of topographical conditions affecting the standard location. The standard location places the well under two power lines and telephone lines that serve the town of Hobbs, New Mexico.

Proration Unit M, Section 19 which is to be dedicated to this well, is under the power and telephone lines that run east and west through the McKinley "A" lease. To avoid these surface obstructions, we request administrative exception to move our location 90 feet south of the southern most orthodox location permitted under Rule 4 of the Special Rules for the Drinkard formation. That would put us 240 feet from the center of the 40-acre location.

Therefore, because of the utility installations, we request your administrative approval of the proposed unorthodox location.






