Dear Mr. Porter:

This is a request for administrative approval for an unorthodox gas well location in the Basin Dakota pool.

It is intended to locate the El Paso Natural Gas Company EPNG A No. 1 well 790' from the South line and 2200' from the East line of Section 21, T-32-N, R-6-W, N. M. P. M., San Juan County, New Mexico. The East half of Section 21 is dedicated to this well.

The East half of Section 21 borders on Lake Navajo and contains a number of steep, rocky bluffs. A well site could not be constructed at an orthodox location for a reasonable cost.

El Paso Natural Gas Company operates all properties within a radius of 790' of the proposed well site.




