Gentlemen:

Application for Approval for Unorthodox Location for MCA Unit Well No. 299

Continental Oil Company, as operator for the MCA Unit, hereby requests approval under the provisions of Order No. R-2403-A to drill MCA Unit Well No. 299 at a location 175' from the north line and 1295' from the west line (Unit D) of Section 27, T-17S, R-32E, Lea County, New Mexico.

As shown on the attached plat this location is 25' from the nearest quarterquarter section boundary line. The well is being drilled in conjunction with our current in-fill drilling evaluation program, and should result in the more efficient recovery of oil in this immediate area.

Since this well is located at least one mile from the nearest outside boundary of the unit, it is respectfully requested that immediate approval of this location be given.
