Pursuant to N.M.O.C.C. Order No. R-4227, it is hereby respectfully requested that approval be granted for unorthodox locations for the Henry S. Birdseye Well No. 3, located in Unit P of Section 21 (inadvertently drilled 165 feet from the south and east lines of Section 21), and for Well No. 5, located in Unit D of Section 27 (drilled 160 feet from the north line and 170 feet from the west line of Section 27), both in Township 20 North, Range 9 West, Chaco Wash-Mesaverde Oil Pool, McKinley County, New Mexico.

Both of these wells have been completed as producible oil wells, and it is my intention that they be put on production until plans for secondary recovery by water flooding for the Chaco Wash-Mesaverde Oil Pool are implemented.

Approval of this request will prevent waste and protect correlative rights, in keeping with the objectives of the N. M. Oil Conservation Commission.

I have inadvertently drilled my No. 3 Santa Fe Railroad well at a non-standard location in Section 21, T20N, R9W, and my No. 5 Santa Fe Railroad well at a non-standard location in Section 27, T20N, R9W, McKinley County, New Mexico.

In order to receive allowables for these wells, I have been asked by the New Mexico Oil Conservation Commission to notify you of these NSL's, and to determine that you have no objection to them, since your State Lease on Section 28, T20N, R9W offsets my wells.

In view of my previous understanding with you and your predecessors as to the ultimate unitization of the Chaco Wash Mesaverde Pool wells, it is our agreement that the captioned wells will prevent waste and protect correlative rights.
