We respectfully request an exception to a standard location (640 acre gas unit) of 1650' FNL & FWL to a non-standard location of 920' FNL & FWL, due to local topographic conditions, on the above captioned well. We further ask the Secretary-Director of the New Mexico Oil Conservation Commission to grant administrative approval to the requested nonstandard location under Rule 104 Section F. Present plans are to move the rig that is drilling our Nan-Bet well about two miles northeast to the subject location. The Nan-Bet well is now drilling below 7500' and should be ready to move in a couple of weeks.

Enclosed is a plat of the topography in Section 36 (640 acre gas unit) all of which is in the Catclaw Draw Unit with Hanagan Petroleum Corporation as unit operator. On this plat is plotted the standard 1650' north and west location, the requested 920' north and west non-standard location, a 990' north and west location and a 1490' north and west location, which shows the relationship of these locations to the topography. This topography can be verified by both the published U.S.G.S. "West Carlsbad 1943" topographic map of the area and personal inspection of the area after these points were surveyed in by a licensed surveyor. Further verification can be furnished by Mr. W. A. Gressett, Supervisor of New Mexico Oil Conservation Commission District II Artesia office, who accompanied me to the location and inspected same.

The standard location falls on the north side of a steep, rocky ridge requiring the removal of a great amount of the ridge for a location, all of which would require dynamitting and considerable expense. A location (1490' N&W) between two ridges is possible, but again would

be expensive as some of the sides of each ridge would have to be cut out (solid rock) plus the west side would have to be dynamited and shoved eastward. This location would affect natural drainage. It would be a tight squeeze to properly rig up the equipment necessary to drill the subject well. A 990' FNL & FWL location again falls on the side of a steep ridge, so by moving it slightly northwest, the proposed location would fall in a nice flat area as shown on the enclosed plat. This location would involve far less cost, less road, and would not affect the natural drainage of the area.

The requested non-standard location is on a State-Federal approved unit (see enclosed unit plat) with all the offsetting acreage affected by moving the location slightly northwest being in the unit area.

Due to the topography and time element, we are asking for administative approval of this non-standard location. Should there be any further information needed, please let us know.



As you will recall, under date of April 21, 1972, we wrote your Santa Fe office at the address below requesting an exception to a standard location for topographic reasons. Subsequently on April 24, we wrote you and your Santa Fe office a letter which was also sent to all of the offsetting oil and gas leasehold owners relative to this request for an exception to a standard location. 


