Dear Mr. Porter:

This is a request for an unorthodox gas well location in the Basin Dakota pool.

It is intended to locate the El Paso Natural Gas Company San Juan 28-7 Unit #220 1080' from the South line and 2480' from the West line of Section 22, T-28-N, R-7-W, Rio Arriba County, New Mexico. The west half of Section 22 is dedicated to this well.

An orthodox location in the Southwest Quarter of Section 22 would place the subject well in very rough terrain, which would make the location and road difficult and very expensive to build and maintain.

All of the offsetting proration units are included in the San Juan 28-7 Unit of which El Paso is the operator.

Plats showing the proposed well location with terrain features and ownership of offset leases are attached.

Water for drilling and completion operations will be obtained from the following location: water hole located in Section 21, T-28-N, R-7-W.

Waste material will be disposed of by burial in the burn pit, latrine, or reserve pit as applicable. There will be no camp nor air strip associated with drilling this well. Upon completion or abandonment of this well, the location will be cleaned and leveled and a dry hole marker placed, if applicable.

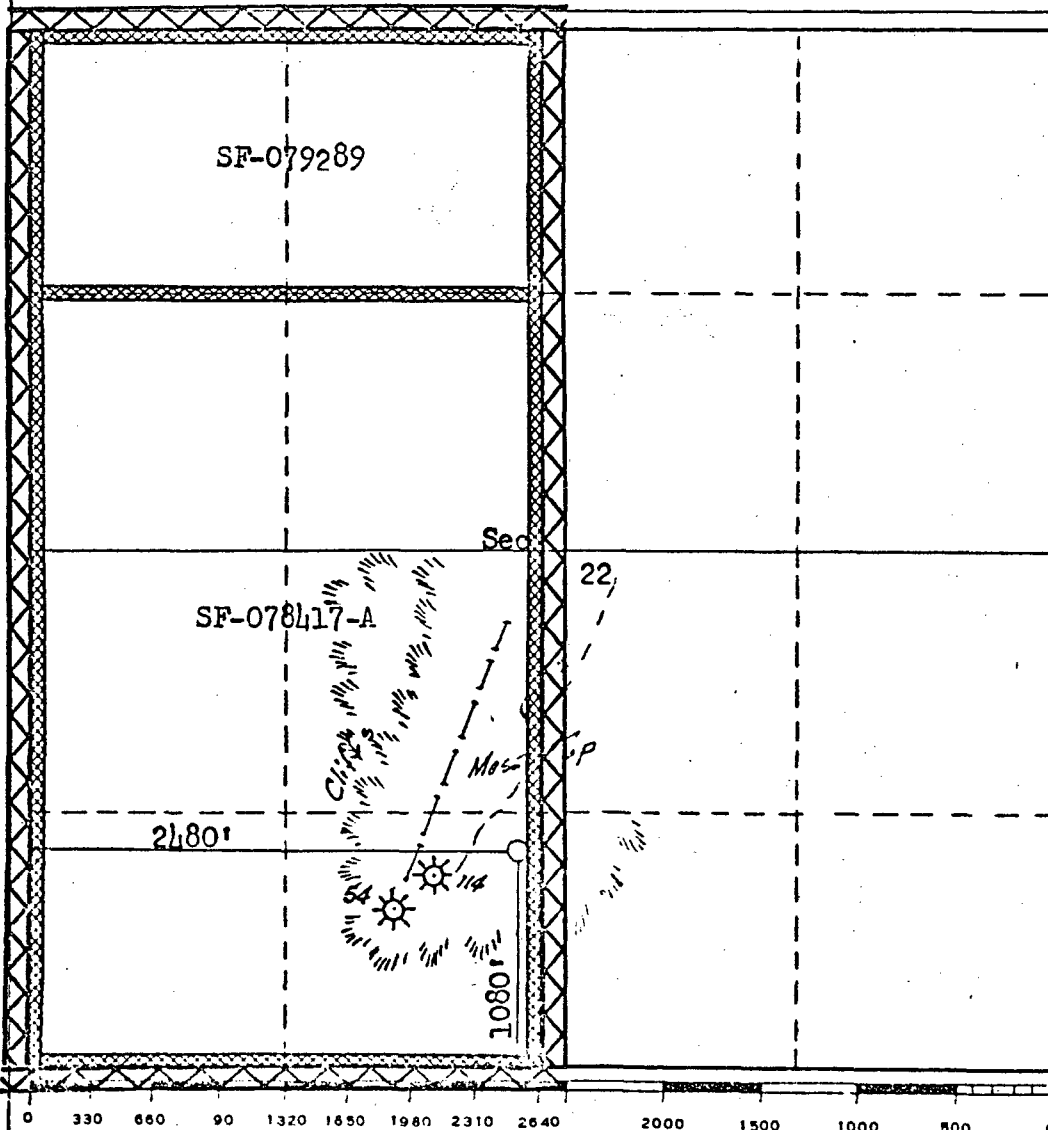
