

Dear Mr. Kapteina:

Mr. Bill Gressett inquired by telephone yesterday, if a location 100 feet East of the orthodox (1980' FN & EL) location might be as acceptable topographically as the unorthodox location (1650' FNL & 1980' FEL) requested.

In response to this question, we feel that the requested unorthodox location should be granted because: (a) the requested location is relatively flat compared to the alternative location which would be on a ridge which drops sharply to the South; (b) the size of the drilling pad could be unnecessarily limited on the alternative unorthodox location due to the obstruction of a junked and abandoned well (1980' FN & EL) and the steep ridge to the South and East.

In addition to the list of offset operators attached to our letter of application, we have sent notification to Allied Chemical Corporation and J. M. Huber Corporation, owners of the offsetting well in the N/2 of Section 14.





Pursuant to Commission Rule 104-F, we hereby make application for administrative approval of an unorthodox location, 1650' FNL and 1980' FEL of Section 15, T-21S, R-27E, in order to drill a well to test the Strawn and Morrow formations.

As evidenced by the attached plat and topography map of the area, an unorthodox location is necessary due to: a) The existence of a plugged and abandoned well on the preferred orthodox location, 1980' FNL and 1980' FEL of Section 15; b) The unorthodox location 1650' FNL and 1980' FEL is relatively flat and accessible in comparison with alternative locations in the SW/4 of the NE/4 of Section 15.




