
Dear Mr. Ramey:

This is an application for administrative approval of the unorthodox location of the Hale No. 4A. The location of this well is 2160' FSL and 1075' FEL of section 34, T-31N, R-8W, San Juan County, New Mexico.

The SE/4 of section 34 is occupied by Simon Canyon with very steep sides and a narrow and inaccessible bottom. There is a narrow point above the canyon where the requested location can be placed. This is the only location available in the SE/4 of section 34.

The offset operators are El Paso Natural Gas Company, Mesa Petroleum and Tenneco Oil Company. They have been notified of this application by certified mail.


