Gentlemen:

Reference captioned and Order No.R-5261. On staking the location approved, 660 feet from North and East lines, Sec.22, T-23-S, R-26-E, it was found that said location fell upon an existing coast to coast coaxial cable system, indicated on attached Form C-102. To prevent damage to or interference with the operation of this system it is required that the approved location be moved 175 feet west. The revised location to be 660 feet from the North line and 835 feet from the East line of Sec.22, T-23-S, R-26-E. I hereby request your consideration for approval of this revised location.



We have no objection to this revised location as offset lease operator.


