### Gentlemen:

Atlantic Richfield Company, as operator of the Empire Abo Pressure Maintenance Project, acting on behalf of itself and the other participating working interest owners, requests administrative approval under the provisions of Order No. R-4549-B, Rule 14, under "Special Rules and Regulations for the Empire Abo Pressure Maintenance Project, to cancel Well No. G-291, which was previously approved under Administrative Order No. NSL 706, dated March 27, 1975. Atlantic Richfield Company at this time, requests permission for one Unit well at a non-standard location, 1315 feet FSL and 1315 feet FWL of Section 33, T-17S, R-28E, Eddy County, New Mexico. The location is 35 feet east and 5 feet south of the Empire Abo Unit Well No.G-291.

Lule 14

Atlantic Richfield Company has drilled an exploratory well. the Empire 33 State Com No. 1, to a total depth of 10,498 feet at a location 1315 feet FSL and 1315 feet FWL of Section 33, T-17S, R-28E, Eddy County, New Mexico. This is the G-301 location within the Empire Abo Unit. The well was non-productive in all horizons below the base of the Abo.

As Unit operator, Atlantic Richfield Company requests administrative approval to complete subject well, Empire 33 State Com No. 1, in the Abo formation, and to rename subject well to Empire Abo Unit Well G-301 (relocation of Empire Abo Unit Well G-291).

The subject well at the non-standard location meets all requirements of Order R-4549-B, Rule 14, said well being located 'no closer than 660 feet to the Unit boundary of said Unit, nor closer than 10 feet to any quarter-quarter section or subdivision inner boundary."




