Dear Mr. Westbrook:

Reference is made to your application dated April 5, 1990 for a non-standard South Brunson Drinkard Abo oil well location for your Drinkard Estate Well No. 6 which was drilled in May, 1977 and completed in the Wantz Granite Wash Pool at a previously approved non-standard oil well location (Division Administrative Order NSL-852, dated June 6, 1977) 1807 feet from the North line and 1542 feet from the East line (Unit G) of Section 25, Township 22 South, Range 37 East, NMPM, Lea County, New Mexico.


It is my understanding that the Wantz Granite Wash zone will be properly plugged back and said well will be recompleted to the South Brunson Drinkard-Abo Pool, which pursuant to General Rule 104.C.I., is unorthodox also.

By the authority granted me under the provisions of General Rule 104.F.I., the above-described unorthodox oil well location is hereby approved.

Further, the NW/4 NE/4 of said Section 25 shall be dedicated to said well forming a standard 40-acre oil spacing and proration unit for said pool.

Said original Division Order NSL-852, shall be placed in abeyance until further notice.
